The proposal was presented by SA(EZ). After due deliberations, it was observed that it is not commercially & structurally viable to provide the entire parking within the plot by constructing more than two basements. It was also observed that in similar case at Netaji Subhash Place, it was decided that part parking will be accommodated in two basements within the plot and rest of the parking to be accommodated in the pool parking/multi-level parking of the District Centre. Taking this as a precedent it was decided that with be Approved proposal observation that part parking will be provided in two basements within the plots and rest of the parking to be accommodated in the pool parking / multi-level parking of SUB CBD Shahdara.
