**Sub:- Inviting Suggestion for Disposal of Pending Restoration of lease cases and Conversion cases.**

DDA is in the process of finalization of pending restoration of lease cases and the cases of conversions from lease hold to free hold which are in conformity with the guidelines/policy of the Govt. of India/MoUD.

While reviewing the aforesaid pending cases, it has been observed that the cases are pending on account of various issues viz court matters/litigation, deficiencies reg. non removal of misuse, etc. which have been intimated to the allottees and have not been complied with by them so far. This not only increases the work load of office/pendency of cases but also increases the grievances of the allottees/applicants.

In order to usher the ease of doing business, DDA has prepared a tentative list of pending restoration of lease cases applied by the allottee or their legal heirs and the tentative list of pending conversion cases which are enclosed as Annexure-'A', & 'B'.

All concerned are hereby requested to go through the aforesaid list and may attend the office of concerned officers of the Land Disposal and Housing Departments of the DDA on any scheduled day for public meetings for familiarizing with the development/status of the cases along with submission of supporting documents, etc. and to facilitate early finalization of their cases and to submit their suggestions, if any, towards disposal of their matters, latest by 31.5.2017.
