In pursuance of MoHUA notification dt. 19.07.2021, it has been decided to regularize the unauthorized occupation of refugees, settled in Delhi in areas other than redevelopment area of 8A, WEA, Karol Bagh, who came from Pakistan and occupied Government land between 16.08.1950 and 30.09.1960.

Applications are invited from all such persons to submit requisite documents with their application on or before 22.03.2022 as per eligibility criterion published on DDA's website (www.dda.org.in) to Dy. Director/OSB, DDA, Room No-213, A block, 2nd Floor, Vikas Sadan, New Delhi-110023. Regularization will be allowed only to the original refugees or their descendants, who have not availed any benefit in Delhi in the form of land or flat/shop on account of their refugee status. Purchasers of the land from the refugees or their descendants will not be given the benefit of the regularization. All such occupants/ persons are directed to submit following documents with their application:-

1. Refugee Registration Certificate (essential).

- 2. Receipts regarding payment of damages assessed by the Authority on or before 30 09 1960.
- 3. Ration Card of 1960.
- 4. Voter list of June 1962.

5. Census slip of 1961 (As Census was held in 1961-Individual Slip).

6. Proper identity proof duly attested by the Gazetted Officer or 1st Class Magistrate.

7. Electric/Water/Telephone Bills, if any, dated back to 1960.

8. Any other letters addressed to the squatter at the place of occupation prior to 1960

by any Govt. Agency.

- 9. An affidavit on a non-judicial paper worth Rs. 10/- duly attested by the 1st Class Magistrate stating therein that you did not get any rehabilitation benefit from the Govt. or any other agency constituted for this purpose in the shape of house, land, loan, plot, grant etc. and that you or your wife/husband or any of your dependent relation including unmarried children do not own any other house/plot/flat in Delhi, New Delhi or Delhi Cantonment.
- 10. Present ration Card.
