Eligibility Criteria: - Only those agencies/ Firms having successfully completed similar works in following manner during last seven years ending last day of the month previous to the month in which tenders are invited, in Government Department or Public Sector Undertaking shall be eligible to apply: -

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost put to tender,

OR

Two similar completed works costing each not less than the amount equal to 60% of the estimated cost put to tender,

OR

One similar completed work of aggregate cost not less than the amount 80% of estimated cost put to tender.

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% calculated from date of completion of work to last date of receipt of application for the tenders.

योग्यता के मानदंड: - केवल वे एजेंसियां/फर्म जिन्होंने टेंडर बुलाए जाने वाले महीने से ठीक पहले वाले महीने के आखिरी दिन तक, पिछले सात वर्षों में सरकारी विभाग या सार्वजनिक क्षेत्र के उपक्रम में इसी तरह के काम सफलतापूर्वक पूरे किए हैं, वे आवेदन करने के लिए पात्र होंगी: -

तीन समान पूरे किए गए काम, जिनमें से प्रत्येक की लागत टेंडर के लिए अनुमानित लागत के 40% के बराबर या उससे अधिक हो,

या

दो समान पूरे किए गए काम, जिनमें से प्रत्येक की लागत टेंडर के लिए अनुमानित लागत के 60% के बराबर या उससे अधिक हो,

या

एक समान पूरा किया गया काम, जिसकी कुल लागत टेंडर के लिए अनुमानित लागत के 80% के बराबर या उससे अधिक हो।

पूरे किए गए काम के मूल्य को मौजूदा लागत स्तर पर लाने के लिए, काम के वास्तविक मूल्य में 7% की साधारण दर से बढ़ोतरी की जाएगी; यह गणना काम पूरा होने की तारीख से लेकर टेंडर के लिए आवेदन प्राप्त होने की आखिरी तारीख तक की जाएगी।

Turnover: -The agency should have average annual financial turnover of at least **30%** of the estimated cost put to tender during the immediate last three consecutive financial years. The value of annual turnover figures shall be brought to the current value by enhancing the actual turnover figures at simple rate of 7% per annum.

टर्नओवर: - एजेंसी का पिछले लगातार तीन वित्तीय वर्षों के दौरान औसत वार्षिक वित्तीय टर्नओवर, टेंडर के लिए अनुमानित लागत का कम से कम 30% होना चाहिए। वार्षिक टर्नओवर के आंकड़ों को मौजूदा मूल्य पर लाने के लिए, वास्तविक टर्नओवर आंकड़ों में प्रति वर्ष 7% की साधारण दर से बढ़ोतरी की जाएगी।

Profit/loss: - The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during last five consecutive years balance sheets (standalone financial statement), duly certified and audited by the Chartered Accountant.

लाभ/हानि: - बोली लगाने वाले को पिछले लगातार पांच वर्षों की बैलेंस शीट (स्टैंडअलोन वित्तीय विवरण) में दो से अधिक वर्षों में कोई नुकसान नहीं हुआ होना चाहिए (यानी टैक्स के बाद लाभ सकारात्मक होना चाहिए); इन बैलेंस शीट को चार्टर्ड अकाउंटेंट द्वारा विधिवत प्रमाणित और ऑडिट किया गया होना चाहिए।

Net worth Certificate: - The agency should submit Networth Certificate of minimum **10%** of the estimated cost put to tender issued by the certified Chartered Accountant having valid UDIN in **Form B-1 (Annexure – B)**.

नेट वर्थ सर्टिफिकेट: - एजेंसी को टेंडर के लिए अनुमानित लागत का कम से कम 10% नेट वर्थ सर्टिफिकेट जमा करना होगा, जिसे वैध UDIN वाले प्रमाणित चार्टर्ड अकाउंटेंट ने फॉर्म B-1 (एनेक्चर – B) में जारी किया हो।

Earnest money amounting to Rs. 12,580/- shall be deposited through IFMIS Portal <https://ifmis.dda.org.in/> and Unique transaction reference of online payment through IFMIS Portal shall have to be uploaded by the bidder in the e-tendering system within the period of bid submission. The AAO will get earnest money verified from IFMIS portal based on the unique transaction reference number against each online payment before the tenders are opened.

टेंडर डॉक्यूमेंट्स को ई-टेंडरिंग पोर्टल, यानी वेबसाइट <https://eprocure.gov.in/eprocure/app> या www.dda.org.in से 03.10.2026 (बिक्री की आखिरी तारीख) तक प्राप्त/डाउनलोड किया जा सकता है। अर्नेस्ट मनी (बयाना राशि) की रकम रु. 12,580/- रुपये IFMIS पोर्टल <https://ifmis.dda.org.in/> के ज़रिए जमा किए जाने चाहिए। बोली लगाने वाले को बोली जमा करने की अवधि के दौरान IFMIS पोर्टल के ज़रिए किए गए ऑनलाइन पेमेंट का 'यूनिक ट्रांज़ैक्शन रेफरेंस' ई-टेंडरिंग सिस्टम में अपलोड करना होगा। टेंडर खुलने से पहले, AAO हर ऑनलाइन पेमेंट के लिए 'यूनिक ट्रांज़ैक्शन रेफरेंस नंबर' के आधार पर IFMIS पोर्टल से अर्नेस्ट मनी (बयाना राशि) का सत्यापन करेगा।
