Order/D.D.) of the offered amount after adjusting Earnest Money of Rs. 10,000/- as precaution money. Balance amount of 75% (including on 100% of the total offered amount) shall be deposited through online/Bank Draft/Pay Order in favour of **"CAU (Sports), DDA"** within 20 days from the date of issue of demand/acceptance Letter or any extension thereof. In case the amount is not deposited within the stipulated period the entire precaution money (25% of the offered amount) deposited by the bidder shall be forfeited absolutely and no claim on this account will be raised by in any forum or court. The bidder shall be informed accordingly.
