
Your percentage rate tender for the above mentioned work has been accepted on behalf of DDA as per terms and conditions as given below:-

1). Estimated Cost	:-	Rs. 51,43,192.00 (Rs. Fifty One Lakh Forty Three Thousand One Hundred Ninety Two Only).
2). Quoted/Accepted rates Tender amount	:-	Rs. 38,57,394.00 (Rs. Thirty Eight Lakhs Fifty Seven Thousand Three Hundred Ninety Four Only).
3). Accepted %age rate under clause 12	:-	25.00% below (Twenty Five Percentage below) of the estimated cost
4). Time allowed	:-	120 days for providing and installation of Play Equipments (Part-A) followed by maintenance of Play Equipments for 3 years (Part-B).
5). Rate	:-	As per DSR - 2018 & Market Rates

6) Terms and Conditions: -

- i) Rates are inclusive of GST.
- ii) The Children Playing equipments shall be installed in the designated parks/Green Areas under jurisdiction to Director Horti. (NW)/DDA at the location as decided by the Engineer-in-Charge.
- iii) All the Playing equipments are to be maintained after the date of completion of Part-A of Schedule for 03 years by the executing agency, the agency shall quote the rate accordingly. Weekly visit or as required by the Engineer-in-Charge has to be made by the agency/Technical Staff of the agency for its proper maintenance.
- iv) The Security Deposit will be withheld as per the Clause (i) of the Supplementary/agreement attached as per annexure -XI in the NIT.
- v) All the raw materials are to be procured as per specifications mentioned in the NIT. The agency shall submit the manufacturer's certificate before execution of the work as per direction of Engineer-in-Charge.
- vi) An amount equal to 5% of the cost of children play equipment shall be withheld from R/A bills, which shall be released @ 2% after satisfactory completion of the maintenance period of 2nd year & rest 3% after satisfactory completion of the maintenance period of 3rd year.
- vii) It will be the responsibility of the agency to keep all the Children Play Equipment in fully working condition for 24x7 during maintenance period for 3 years. In case of Non-compliance of the maintenance of equipments, a penalty of Rs. 1000/- per day per site will be recovered from the running bill on account of maintenance of equipments.

- viii) Payment of Item No. 1 of Part-B of Schedule (Maintenance of Equipments) will be made after satisfactory completion of the maintenance period of 2nd year and 3rd year.
- ix) Do's and Don'ts shall be displayed at every site.
- x) The agency will have to sign the Supplementary Agreement for the Items to be executed under Part-B of the Schedule of Quantity.
- xi) Maintenance of equipment's includes replacement of nut & bolts, damaged parts of equipments etc. to keep all the equipments in working condition complete as per direction of Engineer-in-Charge.
- 7). You are requested to submit a non-judicial stamp paper worth Rs.50/- (Rs.Fifty only) within fifteen days from the date of issue of this letter & signature of the agreement failing which the acceptance of the work shall be withdrawn and the entire amount of earnest money & P.G. forfeited.
- 8). Please note that the time allowed for carrying out the work as entered in the agreement shall be reckoned from the 10 days after the date of issue of this letter to commence the work.
- 9). You are requested to contact AE-I of this Division and start the work at once and creating Project Code.


