पात्रता मापदंड:-

केवल उन एजेंसियों / फर्मों (ओं) को पिछले महीने के आखिरी दिन से लेकर पिछले महीने के दौरान पिछले सात वर्षों के दौरान इसी तरह के कार्यों को सफलतापूर्वक पूरा करना है, जिसमें सरकारी विभाग में निविदाएं आमंत्रित की गई हैं। या सार्वजनिक क्षेत्र का उपक्रम आवेदन करने के लिए पात्र होगा।


