DDA AND WWF INDIA CONDUCTED 'DRAGONFLY BIOBLITZ'

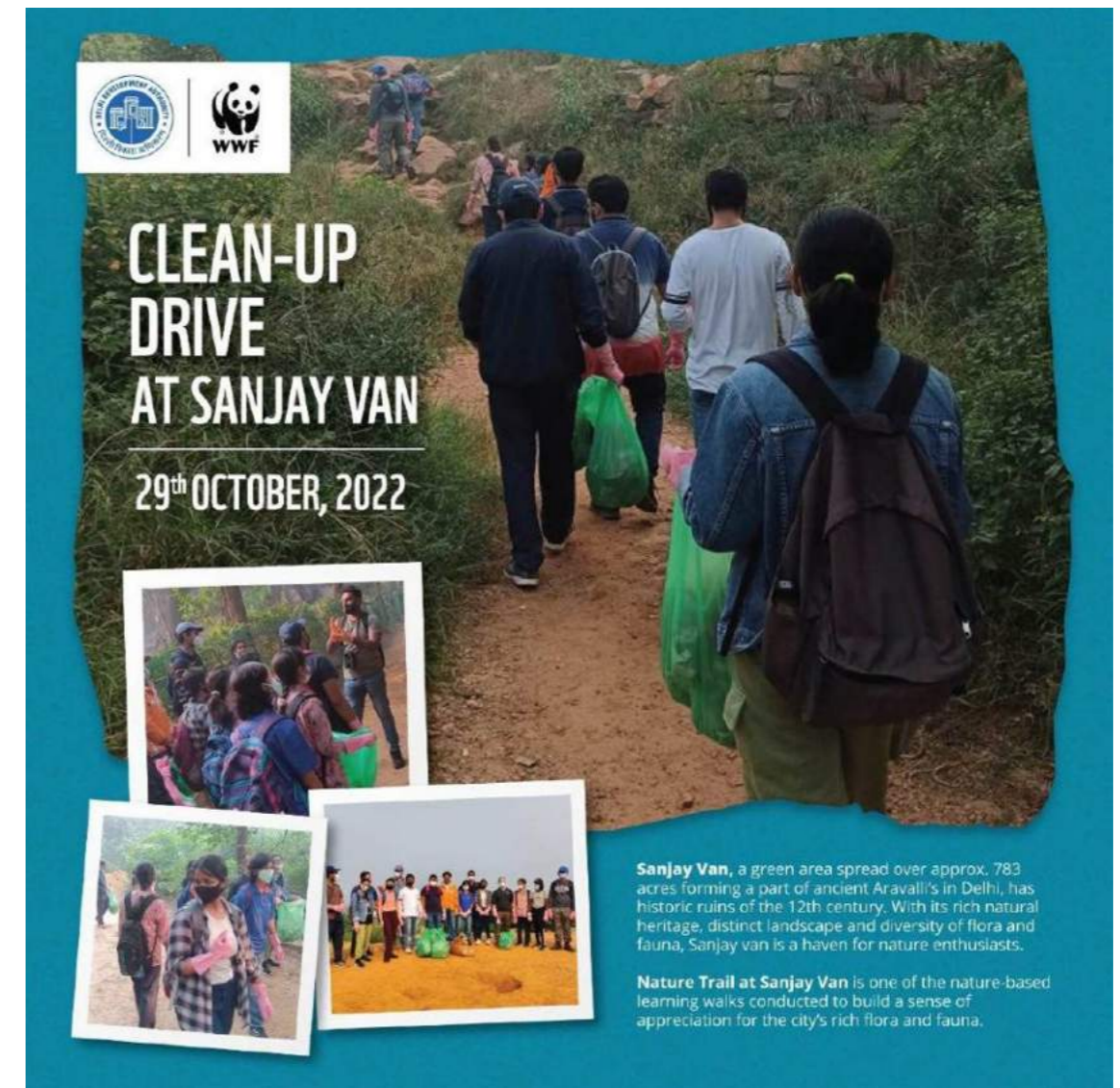

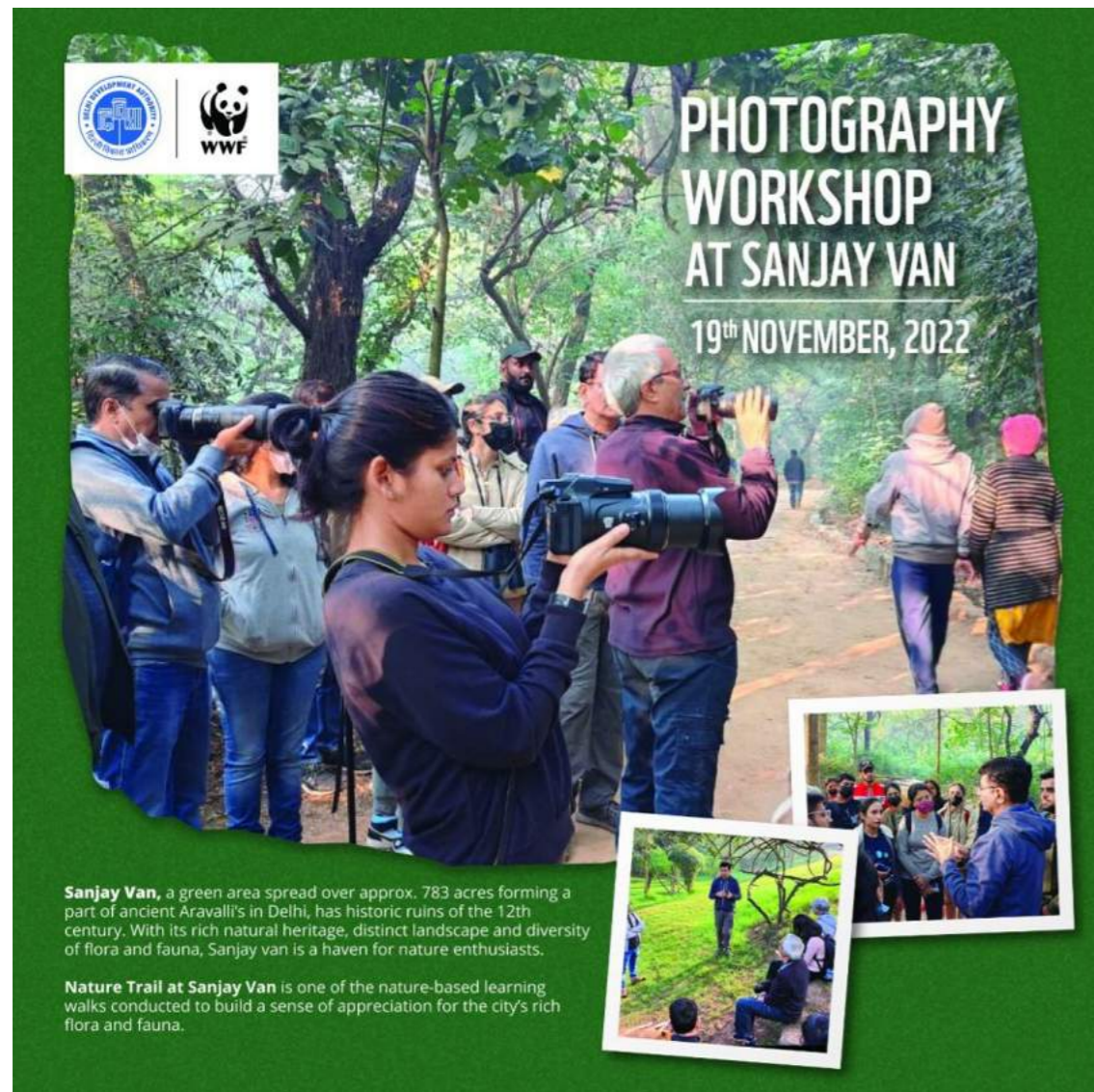
