- 1. The agency should be registered with the GST Department & supposed to furnish a copy of GST Registration and attach the same along with the quotation otherwise the quotation may not be considered and liable to be rejected.
- 2. The experience certificate in any Govt. Organisation /PSU or Private firm.
- 3. No T & P will be issued to the Agency.
- 4. The period of agreement / contract will be for 12 months, it is extendable by one year twice at 5% increase in licence fee on satisfactory performance at the discretion of DDA limited to a maximum of 3 years.
- 5. The work shall be carried out as per direction of Secretary/MDCSC & RE(C)/MDCSC.
- 6. Conditional quotation would not be accepted.
- 7. Debarred agency/ or individual shall not be permitted to participate in the tendering process.
- 8. Any individual who has been debarred is not permitted to take part in any negotiations or represent an agency even if he holds a power of attorney on the agencies behalf. Any agency engaging debarred persons is also liable to debarring.
- 9. Any quotation received through e-mail, post/courier etc. shall be summarily rejected.
- 10. The successful bidder shall deposit the 5% Security deposit in the form of Demand Draft/ FDR of any scheduled bank of RBI in favour of "CAU SPORTS"

DDA". The Security deposit will be enhanced as per extension provided by the competent authority at revise rate.

- 11. Further, if any agency submits a faulty or incomplete tender for the first time, 20% of the earnest money so deposited shall be forfeited. However, if the agency commits fault or submits incomplete tender again in the subsequent tenders and the Competent Authority finds that the default has been willful, negligent or malafide in its intent, the earnest money shall be forfeited absolutely without assigning any reason and the tenderer shall not be allowed to participate in future tendering.
- 12. Agency will pay applicable GST on the quoted license fee separately.
