- 1. Online tenders are invited by the undersigned on behalf of Chairman, Delhi Development Authority (Sports Wing) for the work: Running, Maintenance and Operation of Gymnasium / Fitness Centre at A1B Janakpuri under Dwarka Sports Complex for a period of one year (twelve months) on license fee basis. The tender shall be in two parts viz 'Part -I' containing Technical Bid and 'Part II' comprising 'Financial Bid'. The bid not submitted in accordance with the prescribed manner will not be accounted for.
- 2. Only those agencies / Firm / Person having a minimum turnover of ₹ 20.00 lacs (for Multi-gyms within Sports Complexes) and ₹ 4.00 lacs (for Multi-gyms in Green Areas) in each of the five financial years of the last seven financial years ending 31/03/2021, duly audited & certified by a Chartered Accountant having valid UDIN, are entitled to submit the tenders. It is important to note here that the minimum turnover criteria must be met from gym operations only and this should specifically be certified by the registered Chartered Accountant through a valid UDIN number.
- 3. Only those agencies/ Firm/ Person having experience in Government Department, Public Sector undertaking, Government Autonomous bodies, Govt. Schools and reputed private gyms will be considered.
- 4. The Gymnasium/Fitness Center is located at Dwarka Sports Complex. Tenders shall be opened in the presence of intending tenderers or their representatives at Dwarka Sports Complex.
- 1. अध्यक्ष, दिल्ली विकास प्राधिकरण (स्पोर्ट्स विंग) की ओर से अधोहस्ताक्षरी द्वारा कार्य के लिए ऑनलाइन निविदाएं आमंत्रित की जाती हैं: द्वारका स्पोर्ट्स कॉम्प्लेक्स के तहत ए1बी जनकपुरी में जिमनैजियम / फिटनेस सेंटर का संचालन, रखरखाव और संचालन एक वर्ष की अविध के लिए ( बारह महीने) लाइसेंस शुल्क के आधार पर। निविदा दो भागों में होगी अर्थात 'भाग-1' जिसमें तकनीकी बोली होगी और 'भाग-11' जिसमें 'वित्तीय बोली' शामिल होगी। निर्धारित तरीके के अनुसार प्रस्तुत नहीं की गई बोली को हिसाब में नहीं लिया जाएगा।
- 2. केवल वे एजेंसियां/फर्म/व्यक्ति जिनका पिछले सात वित्तीय वर्षों के पांच वित्तीय वर्षों में से प्रत्येक में न्यूनतम कारोबार 20.00 लाख (स्पोर्ट्स कॉम्प्लेक्स के भीतर मल्टी-जिम के लिए) और 4.00 लाख (ग्रीन क्षेत्रों में मल्टी-जिम के लिए) है। 31/03/2021 को समाप्त, वैध यूडीआईएन वाले चार्टर्ड एकाउंटेंट द्वारा विधिवत लेखापरीक्षित और प्रमाणित, निविदाएं जमा करने के हकदार हैं। यहां यह नोट करना महत्वपूर्ण है कि न्यूनतम टर्नओवर मानदंड केवल जिम संचालन से ही पूरा किया जाना चाहिए और इसे विशेष रूप से पंजीकृत चार्टर्ड एकाउंटेंट द्वारा एक वैध यूडीआईएन नंबर के माध्यम से प्रमाणित किया जाना चाहिए।
- 3. केवल वे एजेंसियां/फर्म/व्यक्ति जिन्हें सरकारी विभाग, सार्वजिनक क्षेत्र के उपक्रम, सरकारी स्वायत्त निकायों, सरकार में अनुभव है। स्कूलों और प्रतिष्ठित निजी जिमों पर विचार किया जाएगा।
- 4. जिमनैजियम/फिटनेस सेंटर द्वारका स्पोर्ट्स कॉम्प्लेक्स में स्थित है। निविदाएं इच्छुक निविदाकारों या उनके प्रतिनिधियों की उपस्थिति में द्वारका खेल परिसर में खोली जाएंगी.

In Part – I of the tender, i.e. Technical Bid, the tenderer shall upload details as listed on next page under "Technical Bid.

Part – II of the tender should contain financial bid indicating monthly license fee (per month) offered by the tenderer. The offer should be given in both words & figures.

# Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.

- 1. The unique transaction reference on NEFT/ RTGS against EMD shall be placed online at specified location for Tender for "Running, Maintenance and Operation of Gymnasium / Fitness Centre at Dwarka Sports Complex. First cover containing "Technical Bid" as well as "reference of EMD".
- 2. The technical Bids shall be opened online at prescribed date & time in the presence of a committee or their representatives by authorized bid openers. Financial Bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Financial Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.

- 3. The Tenderer should furnish Rs. 25,527/- as Earnest Money in the form of RTGS/NEFT .The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However no interest shall be payable on the earnest money.
- 4. The tender shall be submitted online in two parts, viz., technical bid and Financial bid.

  - a. The agency shall be solely liable for any penalty levied by the ESI/EPF departments for not having paid mandatory ESI/EPF contribution and an undertaking on stamp paper to this effect shall be submitted.
  - b. If the agency claims that it is not obligated to get itself registered under the ESIC and EPF acts (and doesn't submit proof of registration with EPFO and ESIC) then the same may be undertaken on a stamp paper.
  - c. All statutory payment including Bonus, covered under any law/statute, shall be the sole responsibility of bidder and DDA shall be protected by the licensee from any financial obligation that may arise due to non-compliances of any government law, policy, guidelines, statute etc.
  - d. Scanned copy of undertaking on a stamp paper that the agency is not blacklisted or debarred by any Govt. /PSU or private organization Agency/Firm/Person/Tenderer at the time of Bid submission.
