1.1 The work is estimated to cost **Rs. 19,53,936/-**-this estimate, however, is given merely as rough guide. Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below. Joints ventures are not accepted. Criteria of eligibility for submission of bid documents.

**1.2 Criteria of eligibility for submission of bid documents**

Contractors who fulfill the following requirements shall be eligible to apply. **Joint ventures are not accepted.**

a) Completion certificates should be issued by the officer not below the rank of Executive Engineer or equivalent will have to be furnished along with the application.

The completion certificate must clearly indicate: -

- Date of completion of works.
- Nature of work with estimated cost.
- That the work has been completed satisfactorily.
- Cost of work done.

**b) Experience certificate: -**

The bidder should have satisfactorily completed the similar works in Central Govt. / State Govt. / PSUs during the Last 7 (Seven) Years ending Last Date of the Month Previous to the one in which Tenders are invited.

c) Definition of Similar Works:-

“SITC of Fire Fighting and Fire Alarm System”.

Three Similar Works each of value not less than Rs. 7,81,574/- (40% of Rs. 19,53,936/-)

OR

Two Similar Works each of value not less than Rs. 11,72,362/- (60% of Rs. 19,53,936/-)

OR

One Similar Work of value not less than Rs. 15,63,149/- (80% of Rs. 19,53,936/-)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at Simple Rate of 7% Per Annum calculated from the ending last day of month previous to the one in which tenders are invited.

If the completion certificate doesn't contain any of the components of Electrical Services, then the firm may submit the separate completion for that specific component as per the following table. (In this case, the bidder shall submit Component-Wise Abstract of Cost of Work).

Similar work	Estimated cost of the component	Eligibility- The firm should have successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders are invited
I. SITC of Firefighting System	11.67 Lac	Three 'Similar Works' each costing not less than Rs. 4.67 Lac or Two 'Similar Works' each costing not less than Rs. 7.00 Lac or One 'Similar Work' costing not less than Rs. 9.34 lacs.
II. Fire Alarm system.	3.60 Lac	Three 'Similar Works' each costing not less than Rs. 1.44 Lac or Two 'Similar Works' each costing not less than Rs. 2.16 Lac or One 'Similar Work' costing not less than Rs. 2.88 lacs.

d) **Solvency Certificate or Net Worth Certificate: -**

Solvency of the amount equal to 40% of the Estimated Cost put to the Tender (ECPT).

OR

Net worth Certificate of Minimum 10% of the Estimated Cost put to Tender issued by certified Chartered Accountants (On the format prescribed in **Form B-1**).

e) **Financial Information:** -The bidder should furnish the Annual Financial Statement for the Last Five Years in (Form- 'A'). Solvency Certificate in (Form- 'B') or Net Worth Certificate in (Form- 'B-1').

The bidder should not have incurred any Loss (Profit after tax should be Positive) in more than Two Years during available Last Five consecutive Balance Sheets.

- 1.3 To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under: "I/we undertake and confirm that eligible similar work(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of the Department, then I/we shall be debarred for bidding in DDA in future forever. Also, if such a Violation comes to the notice of the Department before date of start of work, the Engineer-in-charge shall be free to forfeit the entire amount of earnest money deposit / performance guarantee." (Scanned copy to be uploaded at the time of submission of bid).
2. The intending bidder must read the terms and conditions of CPWD-6 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
3. Information and instructions for bidders will form part of NIT & to be uploaded on website.
4. Information and instructions for bidders posted on website shall form of bid document.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from [www.dda.org.in](http://www.dda.org.in) or central public procurement portal <https://eprocure.gov.in/eprocure/app> free of cost. Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class – II digital signature to submit the bid.
6. But the bid can only be submitted after depositing E-tendering processing fee, and uploading the mandatory scanned documents.

**Note:** Bidders registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:

The bidders who are not registered in DDA and wish to bid in DDA tenders are required to pay annual charge of e-tendering to Secretary CRB, DDA in prescribed form as under:

**Note:** GST shall have to be deposited @ 18% i.e. (CGST @ 9% & SGST @ 9%) along with tendering/processing fee to be deposited in the shape of DD/RTGS in favour of PAO(E/W)/DDA VikasMinar with GST no. for all the registered/non-registered/ to be registered contractors.

Documentary proof in support thereof shall have to be uploaded by the bidders.

Earnest money has to be deposited through separate transaction.

Interested contractor who wish to participate in the bid has also to make following payments.

The unique transaction reference of RTGS / NEFT against EMD shall be submitted to tender opening Authority by the lowest bidder within one week of demand.

The bid submitted shall be opened at 03:30 pm on \_\_\_\_ \* \_\_\_\_\_. Earnest money deposit declaration to be submitted in lieu of EMD.

**Note:-** The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different bids, the entire bid submitted by him will be rejected and he will be debarred from further bidding in DDA in future."

- Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website.
- The intending bidder must have valid class-II digital signature to submit the bid.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.

- Contractor can upload documents in the form of JPG format and PDF format.
- Certificate of financial turn over: At the time of submission of bid contractor may upload affidavit / certificate from CA mentioning financial turnover of last 3 years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
- Contractor must ensure to quote percentage rate. If a tenderer does not quote any percentage above / below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
- The eligibility and / or technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated to them at a later date.
- Pre Bid conference shall be held in the chamber of EE (E)/ELD-1, Seed Bed Park School Block DDA Complex Shakarpur Delhi-92 at 14.30 hrs. on 27.09.2021 to clear the doubt of intending tenderers, if any.**

Earnest money shall be deposited through RTGS/NEFT in the account of Senior A.O. CAU East Zone//DDA having S.B. Account No. 01201110000010 with HDFC Bank Laxmi Deep building Laxmi Nagar Distt. Centre, Delhi - 110092 Branch (IFSC code HDFC0000120). The unique transaction reference of RTGS / NEFT shall have to be scanned & uploaded by the bidder in the e-tendering system within the period of bid

Submission (The Executive Engineer 1 will get earnest money verified from CAU based On the unique transaction reference number against each RTGS / NEFT payment before the Bids are opened).

15. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many tenders are received satisfying the laid down criterion.

**List of self-attested documents to be scanned and uploaded within the period of tender submission, it mandatory to upload scanned copies of all the documents including GST, if documents are not uploaded than bid will become invalid & shall summarily be rejected.**

- i) **Earnest money deposit declaration to be submitted in lieu of EMD as per Annexure-C.**
- ii) Scanned copy of proof of payment made for E-tendering processing fee charges as detailed in para no. 6 above + GST @ 18%.
- iii) Certificate of Registration for /under GST Act and acknowledgement of up to date filed return. / IGST / UTGST / SGST under GST Act 2017 & Tax Clearance certificate.  
If the bidder has not obtained GST registration in the state in which the work is to be taken up, then in such a case the bidder shall upload following undertaking with the bid document "If work is awarded to me, I / we shall obtain GST registration certificate within one month from the date of receipt of award letter or before payment of 1st R.A. bill".
- iv) Bank Solvency Certificate or Net worth Certificate as per attached format (Form 'B' or Form 'B-1').
- v) Scanned copy of Tender Acceptance Letter, as per attached format.
- vi) Corrigendum to tender uploaded before opening of tender (if any).
- vii) Certificates of Work Experience.
- viii) Certificate of Financial Information as per attached format (Form 'A') from CA.
- ix) Affidavit as per provisions of clause 1.3 of Form-6 (NIT).
- x) Integrity Pact
- xi) Valid Electrical license for GNCTD.
- xii) Letter of Transmittal.
- xiii) Documents as per criteria of eligibility for submission of bid documents of para no.-1.2 of Notice Inviting Bid (e-tendering mode).
