Online tenders are invited through e-tendering mode on behalf of Chairman, Delhi Development Authority for the following works at Qutab Golf Course, DDA: The tender shall be in two parts viz 'Part -I' containing Technical Bid and 'Part – II' comprising 'Financial Bid'. Only those agencies/firms/person/renowned restaurants/hotels having a minimum of 5 (Five) years experience in the field of running of snack bar/cafe services to renowned clubs/private golf courses/Institutions/government bodies/PSU's/MNC's with a minimum average annual turnover of Rs. 2.50 crores for the last five financial years may apply.

**In Part-I** of the tender, i.e. Technical Bid, the tenderer shall upload details of ownership/management of the agency, experience of similar nature of works undertaken by them, i.e., copies of award letters and certificates of satisfactory completion, proof of running snack bar/cafe, authenticated proof showing annual turnover for last five financial years, manpower available with them, their qualifications and experience in the field, etc. In case of company / firm, an attested copy of registration certificate and Article of Association is also to be furnished.

In Part – II of the tender should contain the financial bid indicating the monthly license fee (per month) offered by the tenderer. The offer should be given in both words & figures.

- **2.** In case, tender is re invited for any reason, the bidder who has already paid the tender fee previously may not be required to resubmit the tender fee again.
- If any bidder withdraws its bid or act in any manner that leads to cancellation of tender or re-invitation of tender and if the Competent Authority allows such bidder to participate in future tendering, even then no adjustment of tender fee would be allowed as stated in point 2 above.
- 4. In case any contractor fails to make payment by the stipulated closing date of bid submission, the concerned contractor will not be eligible for tendering.
- 5. No hard copy of any document will be required to be submitted by the tenderers till the opening of the tenders. Hard Copies of relevant documents will be required from the highest bidder only

  - b. If the agency claims that it is not obligated to get itself registered under the ESIC and EPF acts (and doesn't submit proof of registration with EPFO and ESIC) then the same may be undertaken on a stamp paper.
  - c. All statutory payment including Bonus, covered under any law/statute, shall be the sole responsibility of bidder and DDA shall be protected by the licensee from any financial obligation that may arise due to non-compliances of any government law, policy, guidelines, statute etc.
