I/we shall be suspended for one year and shall not be eligible to bid for DDA/CPWD tenders from date of issue of suspension order.

Copy of Enlistment order and certificate of work experience as required shall be scanned and uploaded to the e-tendering web within the period of tender submission and certified copy of each shall be deposited in a envelope marked as, "Other Documents".

Both the envelopes shall be placed in another envelope with due mention of Name of work, date & time of opening of tenders and to be submitted in the office of Executive Engineer during the period mentioned above.

Note:-

1. **The bidder will use one UTR for one work only.** In case it is found that he has used one UTR number for different tender, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
 2. The intending tenderer should ensure before tendering in DDA that the requisite fee has been already deposited with CRB. As per decision taken by DDA Class-I, Class II, Class-III, Class-IV & Class-V contractors registered in DDA shall have to deposit Rs.20,000.00, Rs16,000.00, Rs 14,000.00, Rs 10,000.00 and Rs6,000.00 resp. per year. In order to make them eligible to tender for DDA works (vide F.No. EM4(5)98/Vol.II/4267 dated:16.9.2013)
 3.
