**Note:-**

1. **The bidder will use one UTR for one work only.** In case it is found that he has used one UTR number for different tender, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
2. The intending tenderer should ensure before tendering in DDA that the requisite fee has been already deposited with CRB. As per decision taken by DDA Class-I, Class-II, Class-III, Class-IV & Class-V contractors registered in DDA shall have to deposit Rs.20,000.00, Rs16,000.00, Rs 14,000.00, Rs 10,000.00 and Rs6,000.00 resp. per year. In order to make them eligible to tender for DDA works (vide F.No. EM4(5)98/Vol.II/4267 dated:16.9.2013)


