Authority Meeting

Delhi Development Authority held its meeting on 24.11.2021 through video conferencing under the chairmanship of Shri. Anil Baijal - Hon'ble Lt. Governor, Delhi/Chairman, DDA attended by Shri. Manish Kumar Gupta, IAS - Vice Chairman, DDA, and other members of the authority including Shri. Vijender Gupta - MLA, Shri. Somnath Bharti - MLA, Shri. O.P. Sharma - MLA, Shri. Adesh Kumar Gupta Municipal Councillor, North Delhi - Municipal Corporation and Shri. Kailash Sankla - Municipal Councillor, South Delhi Municipal Corporation.

The following major decisions were taken:

Launching of Housing Scheme: The Authority has approved launching of Online Special Housing Scheme for approximately 15,000 flats of different categories at various locations such as Dwarka, Narela, Rohini, Jasola etc. DDA will soon share the further details of the scheme on its website and in leading newspapers / social media. The scheme has the following main features:-

1. The flats offered under this scheme are those which remain unsold in previous housing schemes of DDA.

2. The flats are being offered at the old rates/cost in relaxation of the costing policy of DDA which is updated during every financial year based on the appreciation/depreciation of land cost/building as the case may be.

3. The flats at Narela sub-city are being offered after taking several remedial measures in terms of improvement of infrastructure, security and connectivity on the basis of suggestions/feedback of the allottees/residents of the area.

4. The allottees will be eligible for subsidy under PMAY scheme of the central govt. if they avail home loan from the bank/financial institution.

5. The entire process from application to allotment and possession is being done through online mode. The allottee needs to visit DDA office only for execution of CD.

Amendment in the DDA Policy to mitigate risks of prospective bidders for upcoming in situ rehabilitation projects: To expedite the process of in situ slum redevelopment/rehabilitation, the following provisions were approved by the Authority:

1. Sharing of risk of the developer in case of foreclosure of the project or delay in the stipulated period of execution of the project (3 years) on account of reasons attributable to DDA.

2. The provision for enforcement of vacation of premises for undertaking in situ projects by allowing penal action against the dweller who fails to cooperate with the developer/concessionaire/DDA at any stage causing delay in implementation of in situ slum rehabilitation/redevelopment project.

Fixation of Predetermined Rates (PDRs) for allotment of land: The Predetermined Rates (PDRs) for allotment of Land to Transport Traders at IFC Holambi Kalan, Narela was also approved by the Authority. As per the provision of MPD 2021, godowns of transport traders existing in the walled city and special areas are required to be shifted to Integrated Freight Complex at Holambi Kalan, Narela where goods booking at transport agency offices is a permitted activity. The proposal will now be sent to the ministry for final approval and notification and will kick-start the process of allotment of plots to transport traders. As per the LOP, each eligible transport trader will be allotted a 50 sqm. plot with an FAR of 250.

Board of Enquiry and Hearing on Draft Master Plan Delhi - 2041

DDA conducted its 5th Board of Enquiry and Hearing Meeting on 01.11.2021 on the suggestions/objections for the Draft Master Plan for Delhi - 2041 through the online mode. Earlier four meetings of the Board have taken place viz; on 18.10.2021, 20.10.2021, 25.10.2021 & 27.10.2021. In the meeting held on 01.11.2021, more than 1450 participants were invited and given opportunity to submit their objections/suggestions orally before the Board.



During this hearing, issues of Development Control Norms (DCN) of Draft MPD-2041 mainly related to redevelopment of Convenient Shopping Centres (CSC) & Local Shopping Centres (LSC), mixed use provisions, other activities allowed in residential areas, redevelopment of industrial plots; enhancement of FAR, ground coverage & height of hospitals and educational institutions, permissibility of grocery shops in residential areas were heard in which participants have provided their valuable suggestions.



Meeting Day 6

DDA conducted its 6th board of enquiry and hearing Meeting on 02.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. Earlier five meetings of the Board have taken place viz; on 18.10.2021, 20.10.2021, 25.10.2021, 27.10.2021 & 01.11.2021.

In the meeting held on 02.11.2021, more than 3200 participants were invited and given opportunity to submit their objections/suggestions orally before the board. During this hearing, objections/ suggestions regarding updating list of industries, issues of Master Plan roads, proposed land use plan and unauthorised colonies were heard in which participants provided valuable suggestions.



Meeting Day 7



DDA conducted its 7th Board of Enquiry and Hearing Meeting on 08.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. Earlier six meetings of the board have taken place viz. on 18.10.2021, 20.10.2021, 25.10.2021, 27.10.2021, 01.11.2021 & 02.11.2021 respectively.

In the meeting held on 08.11.2021 more than 3500 participants were invited and given opportunity to submit their objections/suggestions orally before the Board. During this hearing, objections/suggestions regarding issues of proposed master plan roads, proposed land use plan, and registration of unauthorised colonies under PM UDAY were heard in which participants provided valuable suggestions.

Meeting Day 8

DDA conducted its 8th Board of Enquiry and Hearing Meeting on 10.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. In the meeting held on 10.11.2021, more than 4300 participants were invited and given opportunity to submit their objections/suggestions orally before the Board. During this hearing, objections/suggestions regarding issues of proposed Master Plan roads, proposed land use plan, industrial areas, mixed use/ commercial streets and registration of unauthorised colonies under PM UDAY were heard in which participants provided valuable suggestions.



Meeting Day 9

DDA conducted its 9th Board of Enquiry and Hearing meeting on 15.11.2021 on the objections/ suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. Earlier eight meetings of the Board had taken place viz. on; 18.10.2021, 20.10.2021, 25.10.2021, 27.10.2021, 01.11.2021, 02.11.2021, 08.11.2021 & 10.11.2021 respectively.

In the meeting held on 15.11.2021, more than 1000 participants were invited and given opportunity to submit their objection/suggestions orally before the Board. During this hearing, objections/suggestions regarding issues of transit oriented development, land pooling policy, pollution, green development areas, proposed Master Plan roads, proposed land use plan, industrial areas, mixed use/ commercial streets, public art, increase of FAR and ground coverage for schools, transferrable development rights, registration of unauthorised colonies under PM UDAY and implementation of Draft MPD-2041 were heard in which participants provided their valuable suggestions.



Meeting Day 10

DDA conducted its 10th Board of Enquiry and Hearing Meeting on 17.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. Earlier nine meetings of the Board had taken place on 18.10.2021, 20.10.2021, 25.10.2021, 27.10.2021, 01.11.2021, 02.11.2021, 08.11.2021, 10.11.2021 & 15.11.2021 respectively.



In the meeting held on 17.11.2021, participants from various government agencies, institutions, professional bodies were invited and given opportunity to submit their objections/suggestions orally before the Board. During this hearing, objections/suggestions regarding issues of commercial mixed-use streets, enhancement of FAR & ground coverage for industrial & commercial complexes upgradation of physical infrastructure, permissibility of activities, increase in building heights, conservation of heritage structures, relaxation in parking norms, encroachment of govt. lands, planning zones boundary, redevelopment of walled cities, conversion charges, management of vending zones, regular satellite mapping of city to check unauthorised construction, implementation of land pooling, revival of water bodies & cleaning of drains etc. were heard in which participants provided their valuable suggestions.



Meeting Day 12

DDA conducted its 12th Board of Enquiry and Hearing Meeting on 24.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. In the meeting held on 24.11.2021, representatives/members from hawkers federation, RWAs, NGOs, market associations, traders welfare associations etc. were invited and given opportunity to submit their objections/

suggestions orally before the Board. During this hearing, objections/suggestions regarding issues of pollution control, traffic congestions & parking management, revival of water bodies and drains, inter agencies coordination, mixed use streets, green belt, regularisation of warehouses & godowns, redevelopment of industries, street vendors & hawkers, other activities in residential areas, provisions for local shopping centres/convenient shopping centres, conversion charges, provisions of redevelopment/regeneration schemes etc. were heard in which participants provided their valuable suggestions.



Meeting Day 13

DDA conducted its 13th Board of Enquiry and Hearing Meeting on 29.11.2021 on the objections/suggestions for the Draft Master Plan for Delhi - 2041 through the online mode. In the meeting held on 30.11.2021, by concluding the current 14 - day Board of Enquiry and Hearing Meeting schedule, representatives / members from national hawkers federation were invited to make their physical presence and given opportunity to submit their objections/suggestions orally before the Board.



During this hearing, objections / suggestions regarding issues of provision of civic facilities for vendors/ hawkers, allocation of space for vending zones, declaration of vending zones & no vending zones, incorporation of relevant provisions of street vending act in MPD 2041 were heard apart from the recommendations of the town vending committee etc., wherein participants provided their valuable suggestions.
