Online percentage rate tenders are invited through E-tendering mode for the following works by the Executive Engineer NMD-2, Mukherjee Nagar Kingsway Camp Delhi-110009 on behalf of DDA upto 3.00 P.M. on date (Mentioned below) from the approved and eligible contractors of appropriate class of the DDA & CPWD and those of appropriate list of MES, BSNL and Railway which shall be opened through e-tendering mode.

Earnest Money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O./CAU/NZ/DDA having SB **account no.0287111000022** with HDFC Bank, B-3-2Ashok Vihar Phase-II, Delhi 110052 Branch (**IFSC Code :- HDFC0000287**). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tender are opened.

Earnest money upto Rs.20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EM is more than Rs.20.00 lacs then the amount of E.M. beyond Rs.20.00 lacs can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.

The officer inviting tenders shall have the right of rejection all or any of the tender and will not be bound to accept the lowest or any other tender.

- i. The bidder/tenderer will use one UTR for one work only. In case it is found that he has used one UTR Number for different tenders, all the tender submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
- ii. For works costing up to Rs.40.00 lacs of B & R /Civil tender shall be issued to contractor registered with DDA only.
- iii. Proof of registration and the proof of payment i.e. RTGS/NEFT number and its scan copy is to be uploaded.

**The tender shall be Submitted online in two parts viz technical bid and financial bid**

**1. Technical Bid**

The Tenderers are required to upload following documents in technical bid:-

- i) Scan copy of Tender Acceptance letter on the Letter Head of Bidder.
- ii) Scan copy of reference of RTGS/NEFT for EMD.
- iii) Scan copy of PAN No.
- iv) Scan copy of proof the requisite fee deposited with CRB.
- v) Scan copy of certificate of registration with EPFO & ESIC.
- vi) Scan copy of registration of GSTIN.
- vii) Scanned copy of experience certificate of similar works completed during the last seven years in Government Department or Public Sector undertakings (similar work means "total station survey (TSS) or digital mapping of land").
- viii) Notarized Affidavit as per clause 1.2.2 at pages no.-09 of NIT on ₹100/- stamp paper.
- ix) Notarized Affidavit as per clause 1.2.3 at pages no.-10 of NIT on ₹100/- stamp paper.

Any tender found lacking with respect to the necessary information and/or documents and /or EMD, tender cost with the Technical Bid will not be considered.
