SECTION 3: INSTRUCTIONS TO APPLICANTS

Introduction

- 1. The Client (herein called—DDA) proposes to select a Scanning Agency in accordance with the method of selection specified in this document. Applicants are advised that the selection of the Agency shall be on the basis of an evaluation by DDA through the selection process specified in this RFQ-cum-RFP (the —Selection Process). Applicants shall be deemed to have understood and agreed that no explanation or justification on / for any aspect of the Selection Process will be given and that DDA's decisions will be final.
- 2. Applicants are invited to submit Technical and Financial Proposals (collectively called as --the Proposal), in the formats as specified in Section -5 (Standard Forms), for the services required for the Assignment. The Applicant shall submit the Proposal in the form and manner specified in this RFQ-cum-RFP, in relevant sections herewith.
- 3. The Proposal will form the basis for grant of work order to the selected Agency. The Agency shall carry out the assignment in accordance with the Terms of Reference of this RFQ cum RFP (-the TOR).
- 4. Applicants shall bear all costs associated with the preparation and submission of their proposals, and their participation in the Selection process, and presentation including but not limited to postage, delivery fees, expenses associated with any demonstrations or presentations which may be required by DDA or any other costs incurred in connection with or relating to its Proposal. The DDA is not bound to accept any Proposal, and reserves the right to annul the selection process at any time prior to grant of work order, without thereby incurring any liability to the Applicants.
- 5. DDA requires that the Applicant hold DDA's interests' paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The applicant shall not accept or engage in any assignment that may place it in a position of not being able to carry out the assignment in the best interests of DDA and the Project.
- 6. It is the DDA's policy to require that the Applicants observe the highest standard of ethics during the Selection Process and execution of work/assignment. In pursuance of this policy, the DDA:
 - (i) will reject the Proposal for award if it determines that the Applicant has engaged in corrupt or fraudulent activities in competing the work order in question;

- (ii) will blacklist and declare an Applicant ineligible, either indefinitely or for a stated period of time, to be awarded any contract or work order if it at any time determines that the Applicant has engaged in corrupt or fraudulent practices in competing for and in executing the work order or has in any manner tried to defeat DDA's interest.
- (iii) Will forfeit the earnest money and/or security deposit.
- 7. Dispute Resolution: If prior to award of work, any dispute or difference of any kind whatsoever arises between the parties in connection with or arising out of or relating to or under this RFQ - cum - RFP, the parties shall promptly and in good faith negotiate with a view to its amicable resolution and settlement. In the event no amicable resolution or settlement is reached within a period of thirty (30) days from the date on which the above - mentioned dispute or difference arose, such dispute or difference shall be finally settled by Vice-Chairman (VC), DDA, whose decision shall be final.
- 8. The Applicant shall submit his proposal in Electronic form on the GEM/CPP portal. The prospective agency is to submit EMD amount @2% of total cost of the project in favour of Delhi Development Authority. Technical Proposal and Financial Proposal shall be submitted only through GeM/CPP Portal. A copy of the EMD submission proof shall be uploaded on GEM/CPP portal.

- 9. Number of Proposals: No Applicant shall submit more than one Application.
- 10. Right to reject any or all Proposals:
 - Notwithstanding anything contained in this RFQ -cum-RFP, the DDA reserves the right to accept or reject any and all Proposal (s) and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
 - (ii) Without prejudice to the generality of above, the DDA reserves the right to reject any Proposal if:
 - (a) At any time, a material misrepresentation is made or discovered, or

- (b) The Applicant does not provide, within the time specified by the DDA, the supplemental information sought by the DDA for evaluation of the Proposal.
- 11. Disqualification
 - (i) Any misrepresentation/ improper response by the Applicant may lead to the disqualification of the Applicant. The black listed or debarred agencies will summarily stand disqualified and their EMD shall be invoked forfeited.
 - (ii) If such disqualification/ rejection occurs after the Proposals have been opened and the highest-ranking Applicant gets disqualified/ rejected, then the DDA reserves the right to consider the next best Applicant, or take any other measure as may be deemed fit in the sole discretion of the DDA, including annulment of the Selection Process.
- 12. Acknowledgement by Applicant: It shall be deemed that by submitting the Proposal, the Applicant has:
 - (i) made a complete and careful examination of the RFQ cum RFP;
 - (ii) received all relevant information requested from the DDA;
 - accepted the risk of inadequacy, error or mistake in the information provided in the RFQ - cum - RFP or furnished by or on behalf of the DDA;
 - (iv) satisfied itself about all matters, things and information, including matters herein above, necessary and required for submitting an informed Application and performance of all of its obligations there under;
 - (v) acknowledged that it does not have a Conflict of Interest; and
 - (vi) agreed to be bound by the undertaking provided by it under and in term hereof, and
 - (vii) has properly and carefully done due-diligence so as to avoid any type of loss.
 - (viii) has checked & taken care of all types of contingencies which may affect its working and/or affect the properly & timely execution/completion of the work in all respects and the Agency shall not be entitled to any type of loss or damages, whatsoever, whether on account of loss of profit, idle labour and machinery etc. nor shall same be ever paid or awarded to the Agency. However, any genuine loss substantiated and proved by the Agency through cogent evidence may be considered. The decision on any such genuine loss as may be taken by the Vice-Chairman, DDA shall be final and

binding and shall not be challengeable in the Arbitration proceedings.

13. The DDA and/ or its advisors/ consultants, officers, officials shall not be liable for any omission, mistake or error on the part of the applicant in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFQ - cum- RFP or the Selection Process, including any error or mistake therein or in any information or data given by the DDA and/ or its consultant. Applicants are sincerely advised to cross-check and correct every information, data and statement etc. made in this RFP.

Clarification and amendment of RFQ - cum - RFP documents

- 15. Applicants may seek clarification on this RFQ cum RFP document, before the last date mentioned in the Data Sheet 1. Any request for clarification must be sent by standard electronic means (PDF or word file). DDA's e -mail is mentioned in the Data Sheet 1. The DDA will endeavour to respond to the queries prior to the Proposal Due Date. The DDA will post the reply to all such queries on its official website and GeM/CPP portal only.
- 16. At any time before the submission of Proposals, the DDA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Applicant, modify the RFQ cum RFP documents by an amendment. All amendments/ corrigenda will be posted on the DDA's Official Website and GEM/CPP Portal. In order to afford the Applicants a reasonable time for taking an amendment into account, or for any other reason, the DDA may at its discretion extend the Proposal Due Date.

However, no action or claim shall lie against DDA, even if no clarification or information is provided by it and the selections process shall not be annulled nor the date will be postponed for this reason. The bidder should submit its bid at its own understanding and risk & cost.

Pre-Bid Meeting

17. Date of Pre-Bid Meeting and venue is mentioned in the Data Sheet 1. Applicants willing to attend the pre-bid should inform DDA beforehand in writing through email. The maximum number of participants from an applicant, who chose to attend the Pre-Bid Meeting, shall not be more than two per applicant. The representative's attending the Pre-Bid Meeting shall accompany with an authority letter duly signed by the authorized signatory of his/her organization.

18. Pre-Bid Meeting of the Applicants will be convened off -line at the designated date, time and place. During the course of Pre-Bid Meeting, the Applicants will be free to seek clarifications and make suggestions for consideration of the DDA. The DDA will endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent and competitive selection process.

Earnest Money Deposit

19. The prospective agency is to submit EMD amount @2% of total cost of the project in favour of Delhi Development Authority.

Disqualification to participate in the tender process

- 20. Any entity including an individual or a group of individuals which has been barred by the Central Government, any State Government, a statutory authority or a public sector undertaking, as the case may be, from participating in any project and the bar subsists as on the date of the Proposal Due Date, would not be eligible to submit a Proposal.
- 21. An Applicant should have, during the last 3 (three) years, (a) neither failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Applicant or its Associate, nor (b) been expelled from any project or agreement but subjudice , nor (c) have had any agreement terminated for breach by such Applicant or its Associate but subjudice, nor (d) been expelled but subjudice from any project or agreement, nor (e) have had any agreement terminated for breach by such Applicant or its Associate but subjudice from any project or agreement, nor (e) have had any agreement terminated for breach by such Applicant or its Associate but subjudice. All blacklisted or debarred agencies summarily stand disqualified.

Preparation of proposal

- 22. Applicants are requested to submit their Proposal in English language and strictly in the formats provided in this RFQ - cum - RFP. The DDA will evaluate only those Proposals that are received in the specified forms and complete in all respects.
- 23. In preparing their Proposal, Applicants are expected to thoroughly examine the RFQ cum RFP Document.

- 24. Bid should be valid for the period mentioned in the Data Sheet 1.
- 25. The technical proposal should provide the documents as prescribed in Data Sheet 2 and Data Sheet 3 respectively. No information related to financial proposal should be provided in the technical proposal.
- 26. Failure to comply with the requirements spelt out above shall lead to the deduction of marks during the evaluation. Further, in such a case, DDA will be entitled to reject the Proposal. However, if any information related to financial proposal is included in the technical proposal the applicant shall be disqualified and his proposal will not be considered.
- 27. The Proposals must be digitally signed by the Authorized Representative as detailed below:
 - a. by the proprietor in case of a proprietary firm; or
 - b. by a partner, in case of a partnership firm and/or a limited liability partnership; or
 - c. by a duly authorized person under resolution of the Board, in case of a Limited Company or a Corporation;
- 28. Supplementary information
 - a. Except as specifically provided in this RFQ cum RFP, no supplementary material will be entertained by the DDA, and the evaluation will be carried out only on the basis of Documents received by the closing time of Proposal Due Date as specified in Data Sheet 1.
 - b. Applicants will ordinarily not be asked to provide additional material information or documents subsequent to the date of submission, and unsolicited material if submitted will be summarily rejected.
 - c. For the avoidance of doubt, the DDA reserves the right to seek clarifications in case the proposal is non-responsive on any aspects.
- 29. Preparation of Financial proposal While submitting the Financial Proposal, the Applicant shall ensure the following:
 - Applicants are expected to take into account the various requirements and conditions stipulated in this RFQ cum RFP document. The Financial Proposal should be a lump sum Proposal inclusive of all the costs including all taxes associated with the Assignment.
 - b. All the costs associated with the Assignment shall be included in the Financial Proposal. These shall normally cover remuneration for all the personnel (Expatriate and Resident, in the field, office, etc.), accommodation, fares, transportation, conveyance, equipment, printing of documents, secondary and primary data collection, etc.
 - c. The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption, and

shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered nonresponsive and liable to be rejected.

- d. The Financial Proposal shall take into account all the expenses and tax liabilities and cost of insurance specified in the work order, levies and other impositions applicable under the prevailing law. For the avoidance of doubt, it is clarified that all taxes, shall be deemed to be included in the cost shown under different items of Financial Proposal.
- e. The proposal should be submitted as per the standard Financial Proposal submission forms prescribed in this RFQ cum RFP.
- f. Applicants shall express the price of their services in Indian Rupees (INR) only.
- 30. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services and should be stated in INR only. No extra, additional, or further amount shall be paid by the DDA over & above the rates quoted by the bidders. Omissions, if any, in costing of any item shall not entitle the Applicant to be compensated and the liability to fulfil its obligations as per the Terms of Reference within the total quoted price shall be that of the Applicant.
- 31. GST or any other tax, levy or Cess in respect of input for or output by this contract shall be paid by the Agency and DDA shall not entertain any claim whatsoever in this respect.

Submission, receipt and opening of proposals

- 32. The Proposal shall be submitted through GEM/CPP Portal, url mentioned in data sheet 1). The procedure for filing of e -tender is provided on the portal. The applicants are advised to familiarize themselves with the pro cess in advance to avoid any inconvenience at a later stage. Files uploaded on the portal should have file name in accordance to following format [form_name.applicant_name]. Applicant name should contain only first two words of its name.
- 33. The Authorized Representative of the Applicant should authenticate EMD Details, Pre Qualification, Technical and Financial proposal using his digital signatures.
- 34. Authorized Representative's authorization should be confirmed by a resolution/power of attorney by the Board /competent authority accompanying the Proposal (Pre Qualification Proposal).
- **35**. Only Bids/ proposals submitted On -line on GEM/CPP portal shall be opened. No proposal shall be accepted after the closing time for submission of Proposals.

- Documents to be submitted / uploaded in Technical Proposal are given in Data Sheet-3
- 37. After the deadline for submission of proposals, the EMD and (on line) Technical-Qualification Proposal shall be opened by the Tender Committee in presence of representatives of bidders who choose to be present in the bid opening pro cess at the venue mentioned in Data Sheet 1. It will be evaluated by the Evaluation Committee to evaluate whether the Applicants meet the prescribed Minimum Qualification Criteria. The RFP details containing the Financial Proposals shall remain sealed on the GEM/CPP portal at this stage. Similar will be the process for opening Finavial Bids of bidders who qualify Technical qualification.
- 38. Preparation and submission of Financial Bids
 - a. Schedule of price bid in the form of BoQ_XXXXX.xls
 - b. The Tenderers shall submit the financial bid as provided in BoQ_XXXXX.xls along with this tender document. Bidders are advised to download and quote rates and upload in the site at the respective location.
 - c. Quoted rates must be inclusive of GST, all taxes and duties applicable, and any other charges (if any).
 - d. However, all applicable deductions on account of taxes and duties etc., shall be made by DDA.
 - e. The Form for submission of Financial Bid is Form N and Breakup of Cost is to be provided in Form O.
- 39. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Financial Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
- 40. After the Proposal submission until the grant of the work order, if any Applicant wishes to contact the DDA on any matter related to its proposal, it should do so through email at the address mentioned in the Data Sheet 1. Any effort by the firm to influence the DDA during the Proposal evaluation, Proposal comparison or grant of the work order decisions may result in the rejection of the Applicant's proposal.
- 41. Modification and Withdrawal of Bids: No bid shall be altered/modified after submission to the DDA. In case, the tenderer does not submit the Offer as per terms and conditions, and / or modifies and / or withdraws offer, the EMD shall be forfeited.

Proposal Evaluation

- 42. The technical evaluation as specified in this RFQ -cum-RFP will be carried out for all Applicants . Based on this technical evaluation, a list of technically qualified Applicants shall be prepared in the order of their merit. The Financial Proposals of technically qualified Applicant securing the minimum qualification marks will be opened.
- 43. Prior to evaluation of Proposals, the DDA will determine whether each Proposal is responsive to the requirements of the RFQ - cum - RFP at each evaluation stage as indicated below. The DDA may, in its sole discretion, reject any Proposal that is not responsive hereunder. A Proposal will be considered responsive at each stage only if:

RFP Stage Technical Proposal

- (i) the Technical Proposal is received in the form specified in this RFQ -cum-RFP;
- (ii) it is accompanied by the Earnest Money Deposit as specified in this RFQ -cum- RFP;
- (iii) it is received by the Proposed Due Date including any extension thereof in terms hereof;
- (iv) it does not contain any condition or qualification; and
- (v) it is not non-responsive in terms hereof.

Financial Proposal

- (i) The Financial Proposal is received in the form specified in this RFQ cum RFP;
- (ii) it is received by the Proposed Due Date including any extension thereof in terms hereof;
- (iii) it does not contain any condition or qualification; and
- (iv) It is not non-responsive in terms hereof.
- 44. The DDA reserves the right to reject any Proposal which is non responsive or is a conditional proposal and no request for alteration, modification, substitution or withdrawal will be entertained by the DDA in respect of such Proposals. However, DDA reserves the right to seek clarifications or additional information from the Applicant during the evaluation process. The DDA will subsequently examine and evaluate Proposals in accordance with the Selection Process detailed out below. Any type of rider to the proposal shall make the proposal void.

45. **Technical Evaluation:**

a. The evaluation committee appointed by the DDA will carry out the evaluation of Technical Proposals [Form G] on the basis of the evaluation criteria specified in **Data Sheet 2**.

- b. On the basis of provisional evaluation of technical bids, the Committee constituted for the purpose of evaluation of the tenders, may find it necessary to visit the organizations where similar jobs done by tenderer and/or may confirm on phone the quality of performance and/or may visit tenderer's client premises/service Centre, where the such services are being provided by the Tenderer.
- c. If required, the DDA may seek specific clarifications from any or all Agency (ies) at this stage. The DDA shall determine the technical evaluation (Qualified / not qualified) of the Agency after reviewing the clarifications provided by the Agency (ies). The evaluation committee shall determine the Agency (ies) that qualifies for the next phase on the basis of Minimum Qualifying Technical Score criteria specified in Data Sheet 1.
- d. The Committee will short list the bids according to capabilities and skills of the tenderers as per Technical Evaluation Criteria and open the financial bids of only the short-listed tenderers who are found technically qualified.
- **46. Financial Evaluation:** In this process, the financial proposal of the Agency declared qualified technically shall be opened by indicating the date and time set for opening of its Financial Proposal. The information of this date and time may be sent by registered letter, facsimile, or electronic mail.
- 47. The sum total of all costs (column (e) in Form N) shall be taken as the Financial Bid. The Applicant achieving minimum qualifying Technical criteria, and having the Lowest financial bid will be considered to be th e successful Applicant and will be issued the work order (the Successful Applicant)

Grant of Work Order

48. After selection, a Work Order will be issued, in duplicate, by the DDA to the Successful Applicant and the Successful Applicant shall, within (seven) days of the receipt of the work order sign and return the duplicate copy of the work order in acknowledgement thereof. In the event, the duplicate copy of the work order duly signed by the Successful Applicant is not received by the stipulated date, the DDA may, unless it consents to extension of time for submission thereof, appropriate the Earnest Money Deposit of such Applicant as mutually agreed genuine pre-estimated loss and damage suffered by the DDA on account of failure of the Successful Applicant to acknowledge the work order. 49. Failure of the successful Bidder to agree with the Agreement and Terms & Conditions of the RFP shall constitute sufficient grounds for the annulment of the award, in which event DDA shall invoke the EMD and shall also invoke the PBG of the successful Bidder. Please also see related Clause 23 (iii) as above, and

Article 3: Clause (2): Consequences of Breach (Form-B) – Integrity Agreement.

- 50. Once the quotation of the Tenderer is accepted and the acceptance is communicated to the Tenderer (selected bidder) shall present itself in the office of the DDA and shall execute an agreement within 7 (seven) days, as per Form Q (Draft of Agreement).
- 51. Performance Security:
 - a. The successful Bidder, for due and faithful performance of its obligations and as a pre-condition for signing of Advisory Agreement with DDA, shall be required to submit a demand draft of the amount equivalent to 5% of the tendered cost of the work (Total Fee as given in Financial Bid) as Security Deposit after adjusting the earnest money
 - b. In addition to above, the Successful bidder shall, prior to signing of Agreement and as a condition precedent to its entitlement to payment under this Work order, provide to the DDA, a legal, valid and enforceable Performance Security in the form of an unconditional and irrevocable bank guarantee as security for the performance by the successful bidder of its obligations under this Work order, in the form set out in this work order, in an amount equal 10% (Ten percent) of the total cost of Financial Proposal under this Assignment.

c. The Performance Security shall be obtained from a scheduled commercial Indian bank, in compliance with Applicable Laws (including, in case the Successful bidder is a non-resident, in compliance with applicable foreign exchange laws and regulations).
 d. In the event the Successful Bidder is a joint venture consortium, the Performance Security may be provided by any Member; provided that such Performance Security shall mention the details of this Work order and the other Members.

e. Performance Bank Guarantee shall be in form of an unconditional Bank Guarantee enforceable at any time and substantially in the form annexed with the work order (Form P).

- f. For the successful bidder the PBG as well as Security Deposit shall be kept for a period of 38 months (3 years plus 2 months beyond lapse of engagement).
- 52. The Performance Bank Guarantee (PBG) will be invoked by DDA, in case the performance of the vendor is not found satisfactory during the period of Work.
- 53. The tenderer will not sub-let / sub-contract in part, or in full after getting the Assignment / Award of Work. In the event of tenderer subletting the work / sub - contracting in part or full after the Award of the Work, the tenderer shall be considered to have thereby committed a breach of agreement and DDA shall forfeit the Performance Security Deposit and invoke the Performance Bank Guarantee. The tenderer shall have no claim, whatsoever, for any compensation or any loss on this account.

Signing of Contract

54. Subsequent to receipt of valid Performance Guarantee from the successful Bidder, the parties shall enter into a contract, incorporating all clauses, pre -bid clarifications and the Proposal of the Bidder, between the DDA and the successful Bidder. This RFP and all its clauses, terms & conditions, clarifications shall constitute an integral part of the Contract and shall always be binding upon the Agency in all respects.

Grievance Redressal

- 55. If the Tenderer finds any hindrance in the start of the services resulting in and necessitating an extension of time allowed in the tender, the tenderer shall apply in writing to Vice-Chairman, DDA or Nodal Officer authorized by Vice-Chairman, DDA, for grant of extension of time.
- 56. The extension can be granted by the Vice-Chairman, DDA or Nodal Officer authorized by Vice-Chairman, DDA, in their absolute discretion and if the cause shown is genuine and sufficient.

If for any reason the work is not started or could not be started, the Agency shall immediately issue a notice in writing intimating the same to Nodal Officer and the Vice-Chairman, DDA. Under all circumstances the Agency shall take all possible precautions to mitigate the losses and damages and shall always ensure that minimum loss/damage is caused to the DDA under all the circumstances.

Payment terms

57. The payment terms of the service charges as well as other charges quoted by the successful bidder shall be as per Data Sheet 4.

Confidentiality

- 58. Information relating to evaluation of proposals and recommendations concerning grant of the work order shall not be disclosed to the applicants who submitted the proposals or to other persons not officially concerned with the process, until the winning firm has been notified that it has been given the work order.
- 59. It is specifically clarified that all the records of DDA are quite confidential and the Agency shall always ensure that under no circumstances any of the file and/or page is shared with any unauthorized person.

Fraud and corrupt practices

The Applicants and their respective officers, employees, agents and 60. advisers, partners, directors, stake-holders shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this RFQ - cum - RFP, the DDA will reject a Proposal without being liable in any manner whatsoever to the Applicant, if it determines that the Applicant has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive p practice (collectively the –Prohibited Practices) in the Selection Process. In such an event, the DDA will, without prejudice to its any other rights or remedies, forfeit and appropriate the Earnest Money Deposit, as mutually agreed genuine pre-estimated compensation and damages payable to the DDA for, inter alia, time, cost an d effort of the DDA, in regard to the RFQ - cum - RFP, including consideration and evaluation of such Applicant's Proposal.

Without prejudice to the rights of the DDA under this Clause, hereinabove and the rights and remedies which the DDA may have under the WORK ORDER or the Agreement, if an Applicant or Agency, as the case may be, is found by the DDA to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Selection Process, or after the issue of the WORK ORDER or the execution of the Agreement, such Applicant or Agency shall not be eligible to participate in any tender or RFQ - cum - RFP issued by the DDA during a period of 2 (two) years from the date such Applicant or ICT Agency, as the case may be, is found by the DDA to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.

61. For the purposes of this Clause, the following terms shall have the meaning hereinafter respectively assigned to them. This shall be in addition to any other meaning(s) specified in any law or judgment:

(a) Corrupt practice means

(i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the Selection Process

(ii) for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the DDA who is or has been associated in any manner, directly or indirectly with the Selection Process or the work order or has dealt with matters concerning the Agreement or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the DDA, shall be deemed to constitute influencing the actions of a person connected with the Selection Process;

(iii) save as provided herein, engaging in any manner whatsoever, whether during the Selection Process or after the issue of the work order or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the work order or the Agreement, who at any time has been or is a legal, financial or technical consultant/ adviser of the DDA in relation to any matter concerning the Project:

(b) **fraudulent practice** means a misrepresentation or omission of facts or disclosure of incomplete facts, in order to influence the Selection Process;

(c) **coercive practice** means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the Selection Process;

(d) Undesirable practice means

(i) establishing contact with any person connected with or employed or engaged by the DDA with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or

(ii) having a Conflict of Interest;

(e) **Restrictive practice** means forming a cartel or arriving at any understanding or arrangement among Applicants with the objective of restricting or manipulating a full and fair competition in the Selection Process.

Termination of Contract by DDA

62. If the DDA, for any reason, whatsoever decides to terminate the contract, a written notice of termination to the Bidder shall be given with a notice period of 3 months as per provision of Tender and Fees for the work done approved till the time of termination, shall be made as mutually decided between DDA and the Bidder.

Termination for Default

- 63. Default is said to have occurred
 - (a) If the selected Bidder fails to accept the Work Orders
 - (b) If the selected Bidder fails to deliver any or all of the services within the time period(s) specified in the Work Order or during any extension thereof granted by the DDA.
 - (c) If the selected Bidder fails to perform any other material obligation(s) under the contract.
 - (d) If the selected bidder fails to maintain the secrecy.
 - (e) If the selected bidder in any manner causes any type of loss or damage to the record.
 - (f) If the selected bidder fails to execute the work in time and/or in accordance with the requirements of the DDA.
 - (g) It is clarified that DDA needs the record on urgent basis and any delay in scanning or holding the record can cause huge losses to the DDA, therefore, the Agency shall always ensure that the scanning is done on prompt basis so as to avoid any type of delay, loss or embarrassment to the DDA or its officers etc.
- 64. If the selected Bidder defaults in the above circumstances, a cure period of 30 days will be given to the selected Bidder to rectify the default, faili ng which the selection against this tender will be cancelled and 8.5% of the Work order value will be levied as cancellation charges. DDA can get the work done through alternate sources with the difference in the cost

of getting the work done to be borne by the successful bidder with capping of maximum 10% of the value of the goods/services for which alternative option is sorted to. In the event of termination of contract the security deposit and PBG shall stand forfeited.

- 65. The Contract to be executed with the tenderer (selected agency) may be terminated by DDA for non-performance of any of the clauses of the contract and/or for violation for any terms and conditions of the contract by the tenderer, after serving a prior notice of one month on the registered address of the tenderer or through registered email address of the tenderer.
- 66. If the contract is terminated due to non-performance, underperformance, inferior- performance, defective-performance, nonsubmission of deliverables within prescribed time schedule, inferior quality of reports, non -compliance to instructions, fraudulent practices, corrupt practices and misrepresentation, then fee for that work will not be paid and the Security Deposit & Performance Security (PBG) deposited by Bidder will be forfeited.
- 67. If the contract is terminated due to violation of terms and conditions the Security Deposit and Performance Bank Guarantee will be forfeited.

Penalties

- 68. In case the Bidder fails to execute the work in accordance with the requirements mentioned in this RFP & Contract or violates any of the terms & conditions thereof or fails to adhere to the time frame for starting the work as per the schedule, or any unjustified and unacceptable delay beyond the delivery, installation and commissioning schedule as per contract, will render the bidder liable for penalty or liquidity damages as per the rate as mentioned in the "Data Sheet 5: Service Level Agreement". Measurement of Service Level Agreement (SLA)
 - The SLA metrics provided specifies performance parameters as baseline performance, lower performance and breach. **All SLA calculations will be done on bi-monthly basis.** The SLA also specifies the liquidated damages for lower performance and breach conditions.
 - ii) Payment to the Successful Bidder is linked to the compliance with the SLA metrics.
 - iii) The aforementioned SLA parameters shall be measured per the individual SLA parameter requirements and measurement methods,

through appropriate SLA Measurement tools to be provided by the agency and audited by the DDA or its appointed Consultant for accuracy and reliability.

- iv) DDA shall also have the right to conduct, either itself or through any other agency as it may deem fit, an audit / revision of the SLA parameters. The SLAs defined, shall be reviewed by the Authority on an annual basis after consulting the Selected Bidder and other experts. All the changes would be made by the DDA after consultation with the Selected Bidder and might include some corrections to reduce undue relaxation in Service levels or some corrections to avoid unrealistic imposition of liquidated damages, which are noticed after project has gone live.
- v) Total liquidated damages to be levied on the Selected Bidder shall be capped at 10% of the total contract value. However, DDA would have right to invoke termination of the contract in case the overall liquidated damages equals 10% of total contract value.
- 69. The Service Level Agreements (SLAs):
 - a. The Selected Bidder shall accomplish the scope of work under this Agreement as per the Timelines and as per the Service Level Agreements (Data Sheet 6). If the Selected Bidder fails to achieve the Timelines due to reasons attributable to it, or if it fails to achieve the Service Levels (in the SLAs) for any reason whatsoever, the Systems Integrator shall be liable to pay penalty/liquidated damages as mentioned in the tender.
 - b. In case the Selected Bidder is not solely liable for the breach of Timelines, amount of liquidated damages shall be deducted on proportionate / pro rata basis depending upon the Systems Integrator's extent of fault in such breach of Timelines.
 - c. DDA shall have the right to determine such extent of fault and liquidated damages in consultation with Selected Bidder. Payment of liquidated damages shall not be the sole and exclusive remedies available to DDA and the Selected Bidder shall not be relieved from any obligations by virtue of payment of such liquidated damages. The liquidated damages will be capped as mentioned in Tender.
 - d. Any additional personnel required for managing the operations (as directed by DDA with due notice of 2 months) shall be provided at the same cost as indicated in this financial quote.

Liquidity Damages

- 70. In the event that
 - The Selected Bidder does not perform as per the terms & conditions of the Agreement, or if does not provide or procure fulfilment of any or all of the conditions precedent set forth in the RFP-RFQ tender, and
 - ii) the delay has not occurred as a result of breach of this Contract by the DDA or due to Force Majeure,

the Selected bidder shall pay to the DDA, damages in an amount calculated at the rate of 0.5% (zero point five per cent) of the Performance Bank Guarantee for each week (part of a week being treated as a full week) of delay, up to a maximum deduction of 10% (Ten percent) of the total contract price until the fulfilment of such conditions precedent.

Miscellaneous

- 71. The decision of the Vice-Chairman (VC), DDA with respect to any of the matters pertaining to the RFP-RFQ tender or the agreement or arising there from shall be final and binding, and shall not be called in question in any proceedings or at any forum whatsoever.
- 72. All procedure for the purchase of stores laid down in GFR 2017 (as amended from time to time) shall be adhered-to strictly by the DDA and Bidders are bound to respect the same.
- 73. DDA / Evaluation Committee may independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any Applicant.
- 74. The DDA, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
 - a. Suspend and/or cancel the Selection Process and/or amend and/or supplement the selection process or modify the dates or other terms and conditions relating thereto;
 - consult with any Applicant in order to receive clarification or further information;
 - retain any information and/or evidence submitted to the DDA by, on behalf of and/or in relation to any Applicant; and/or
 - reject any tender(s), in which any prescribed condition(s) is/are found incomplete in any respect and at any processing stage.
 - e. Call for all or any record from the Agency.
- 75. It shall be deemed that by submitting the Proposal, the Applicant agrees and releases the DDA, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/or performance of any

obligations hereunder, pursuant hereto and/or in connection herewith and waives any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or future.

- **76.** All documents and other information provided by DDA or submitted by an Applicant to DDA shall remain or become the property of DDA. Applicants and the ICT Agency, as the case may be, are to treat all information as strictly confidential. DDA will not return any Proposal or any information related thereto. All information collected, analysed, processed or in whatever manner provided by the Applicant to DDA in relation to the assignment shall be the property of DDA.
- 77. The DDA reserves the right to make inquiries with any of the Applicants about their previous experience record.

Important Note

- **78**. Tender documents consisting of eligibility criteria, scope of work, and other details to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents may be downloaded from GeM/CPP Portal (url mentioned in Data Sheet 1) free of cost.
- 79. Intending agencies/tenderers need to register themselves on the GEM/CPP portal. Aspiring Tenderers who have not enrolled/registered on GeM/CPP should enroll/register before participating through the GEM/CPP website.
- **80**. Tenderers can access tender documents on the website, fill them with all relevant information and submit the completed tender document into electronic tender on the GEM website/ CPP portal.
- 81. Tenders and supporting documents should be uploaded through eprocurement. Hard copy of the tender bids will not be accepted.
- 82. Bidders will be required to submit "Integrity Pacts" on Rs. 100 non judicial stamp paper in two original copies.
- 83.

Instructions for Online Bid Submission

- 84. Contractor/Bidder may go through the tenders published on the site and download the required tender documents/schedules for the tenders he/she is interested.
- 85. After downloading / getting the tender document/schedules, the Bidder should go through them carefully and then submit the documents as asked, otherwise bid will be rejected.

- **86.** If there are any clarifications, this may be routed through GeM/CPP Portal. Bidder should take into account the corrigendum published before submitting the bids online.
- 87. It is construed that the bidder has read all the terms and conditions before submitting their offer. Bidder should go through the tender schedules carefully and upload the documents as asked; otherwise, the bid will be rejected.
- 88. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in .PDF/.xls/.rar formats or as applicable for acceptance on GEM/CPP portal. If there is more than one document, they can be clubbed together and can be provided in the requested format. Bidders Bid documents may be scanned with 100 dpi with black and white option.
- 89. If there are any clarifications, this may be obtained through the GeM/CPP portal, or during the pre bid meeting, if any. Bidder should take into account the corrigendum published from time to time before submitting the online bids. In case, no clarification is given by the DDA, the bidder should submit his bid at his own risk & cost, and shall be stopped from making any claim on that account at any later stage. No such claim at any later stage shall be admitted.
- **90.** The Bidders can update well in advance, the documents such as certificates, annual report details etc.as per GeM/CPP guidelines.
- 91. Bidder should submit the EMD as specified in the tender. In case, bidder intends to submit EMD through Demand Draft, the original should be posted/couriered/given in person to the Tender Inviting Authority, within the bid submission due date & time for the tender or as indicated in the tender. Scanned copy of the instrument should be uploaded as part of the offer.
- 92. While submitting the bids online, the bidder reads the terms & conditions and accepts the same to proceed further to submit the bid packets.
- **93.** The details of payments made through RTGS/NEFT should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise submitted bid will not be acceptable or liable for rejection.
- 94. The bidder has to digitally sign and upload the required bid documents one by one as indicated. Bidders to note that the very act of using DSC for downloading the bids and uploading their offers shall be deemed to be a confirmation that they have read all sections and pages of the bid document including General conditions of contract without any

exception and have understood the entire document and are clear about the requirements of the tender requirements.

- **95.** The bidder has to upload the relevant files required as indicated in the cover content. In case of any irrelevant files, the bid will be rejected.
- **96.** If the price bid format is provided in a spread sheet file like BoQ_xx xx.xls (XXXX ...), the rates offered should be entered in the allotted space only and uploaded after filling the relevant columns. The Priced-bid/BOQ template must not be modified / replaced by the bidder; else the bid submitted is liable to be rejected for this tender.
- **97.** The bidders are requested to submit the bids through GeM/CPP portal only. The Tender Inviting Authoirty(TIA) will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour.
- **98.** After the bid submission in the GeM/CPP portal, the acknowledgement number generated by the system, if any, should be printed by the bidder and kept as a record of evidence for online submission of bid for the particular tender and will also act as an entry pass to participate in the bid opening date.

DDA will not be under obligation to give clarifications for doing the aforementioned and no action for any type of damage or loss shall be brought against the DDA nor shall any of the bidders/interested person shall be entitled to any type of loss or damage on this account. 103. DDA also reserves the right to modify/relax any of the terms & conditions of the tender by declaring / publishing such amendments in a manner that all prospective bidders / parties to be kept informed about it.



SCOPE OF WORK

- 1. DDA has operationalized the e-Office a digital Workflow office product solution from National Informatics Centre (NIC) for (a) establishing a paperless environment in its office, and (b) transforming the existing manual, paper driven processes in to electronic workflow.
- 2. Further, DDA proposes to implement NIC's E-HRMS application for the purpose of digitizing the service records and conducting HR processes in an on-line mode.
- 3. Further, DDA at its reception counters (called R&I) in Vikas Sadan and Vikas Minar receives paper dak / applications (through hand delivery / india-post / speed-post). These paper dak is required to be uploaded in e-office and marked (electronically) to the recipient officer on e-office.
- 4. To in order to implement these software applications, DDA needs services of an agency which is required to do the following activities:
 - a. scan and digitize the paper records (in form of paper files and service books)
 - b. create E-file in e-office application after scanning and uploading on e-office
 - c. Create e-service book in e-HRMS application after scanning and uploading in EHRMS software.
 - d. Extract data from the service books and do structured data-entry of service book data as specified in Datasheet 6 in order to create e-service book in the e-HRMS application. This may require entry of hand written content in the service book.
 - e. Data Entry of Bank & Branch Scrolls in Bhoomi / Aawas Software
 - f. Data Entry of Challans in Bhoomi Aawas Software.
 - g. All PDF files as far as possible shall be made in searchable mode.
- 5. The service agency will be required to set-up scan desks at the reception counters (R&I desks) for scanning the dak and uploading it in e-office on daily basis.
- 6. The physical files and service books will be returned to the DDA Recordkeeper incharge with proper MIS and handing over/ taking over process to prevent loss of records.
- 7. The daily dak received will be handed over to DDA's Record Keeper incharge with proper MIS and handing over/ taking over process to prevent loss of records.
- 8. Following shall be the process for carrying out the scanning and cleaning of documents for uploading in E-office:-


- a. The DDA officials/user department shall request for creation of file in E-office.
- b. The tenderer/data entry agency shall receive the original files in paper format from DDA officials and scrutinize the documents contained therein. (and issue receipt thereof to the person delivering).
- c. The correspondence sheets and noting sheets of file have to be scanned separately. It may be noted that the file noting is written on both sides of the paper and the correspondences too sometimes are printed on both sides of the paper.
- d. Once the documents are scanned, the tenderer shall clean the scanned images in the best possible form so as to get a good readable quality image of the documents. Orientation of the scanned image should also be corrected so that electronically it is easily readable. The pdf file so created should have the scanned image(s) in the correct sequence and as far as possible shall be in searchable mode
- e. In case the document is not of the required quality for the satisfaction of the user than the same shall be re-scanned by the tenderer at no extra cost;
- f. After scanning is carried out a file shall be created in E-office and scanned copy of the respective noting sheets and correspondence sheets shall be attached in the E-office file.
- g. The E-office file, complete in all respects shall be then forwarded to the originating user department in DDA. Concerned department can access and carry out further processing on the file.
- h. Daily MIS report of work shall be generated and handed over to the Record Keeper.
- 9. Removal of the tags, all-pins, staple pins etc. as may be required for work shall be carried out by the tenderer. After completing the scanning, documents have to be placed back in the same file by tenderer in the original sequence duly tagged and stapled.
- 10. Scope of work includes and starts from the point when the files and pages are handed over to Agency for scanning and ends only when the same are handed back by the Agency against proper receipt. Till the time the file and pages remained with the Agency, it alone shall be responsible for the safe custody thereof and no extra payment shall be made therefor.
- 11. <u>Agency alone shall be responsible for the safe custody of all the files and pages given to it for scanning.</u>
- 12. Wherever a document / paper is mutilated or has become damaged, etc., the tenderer shall take special care to protect the documents in the process of scanning and place the same back into the file duly intact;

- 13. The tenderer shall maintain number of noting sheets and correspondence pages received in each file, number of noting sheet / correspondence pages scanned from each file; After scanning / digitization, the paper-file will be restored to its original form by the agency. The agency will check and scrutinize the papers to ensure no loss / mixing of papers from the file.
- 14. Files are required to be untagged for scanning and after scanning the files are to be tagged in the same sequence as was before making it untagged. Thus tagging, untagging, scanning etc. all are parts of this scope of work.
- 15. In case any preservation of mutilated/damaged document is required, the Agency, with the approval of DDA Nodal officer, will do appropriate preservation (such as storing in polythene cover) to prevent it from further damage before restoring the file. (agency will be paid preservation charges for the same).
- 16. After completion of the process on the File Cover, following rubber stamp shall be affixed and details entered.



- 17. At the end of the day, all files (whose scanning has been completed and converted in e-file) will be handed over to the DDA's Record Keeper of the concerned Department.
- 18. Following shall be the process for carrying out the scanning and cleaning of Service Book for uploading in E-HRMS:
 - a. The DDA officials/user department shall request for creation of e-Service books.
 - b. The tenderer/data entry agency shall receive the original Service Books in register format from DDA officials and scrutinize pages contained therein. (and issue receipt thereof to the person delivering).
 c. The Title sheets [Bio-data and Certificates and attestation] and Service entry sheets of file have to be scanned separately. In case of loose sheets in the service book, the same have to be scanned separately. Blank sheets of the service book will not be scanned.
 - d. Once the documents are scanned, the tenderer shall clean the scanned images in the best possible form so as to get a good readable quality image of the documents. In case the document is not of the required quality for the satisfaction of the user than the same shall be re-scanned by the tenderer at no extra cost;


- e. After scanning is carried out a Service file shall be created in E-HRMS and scanned copy of the respective title sheets and service entry sheets shall be attached in the E-Service file.
- f. Data Entry of fields in the E-HRMS application will be carried out by the agency by extracting / reading information from the service book.
- g. The E-Service file, complete in all respects shall be then Saved in E-HRMS.
- h. Daily MIS report of work shall be generated and handed over to the Record Keeper.
- 19. Service Books are in a bound register formats. The Agency will have to deploy appropriate kind of overhead scanner to be able to scan such service books.
- 20. After completion of the process, the Agency will create e-service book in the E-HRMS application and put a rubber stamp on the Face of the Service Book indicating –



- 21. At the end of the day, all Service (whose scanning has been completed and converted in eservice book) will be handed over to the DDA's Record Keeper of the HR Department.
- 22. The Agency will deploy a Quality Check team to do QC of data-entry work so as to ensure that the data-entry of service book data is correct and complete.
- 23. Following shall be the process for carrying out the scanning and cleaning of dak for uploading in E-office:
 - a. The Dak at the R&I counters will be received the agency personnel.
 - The tenderer/data entry agency shall receive the original dak in paper format from the person delivering and scrutinize the documents contained therein and issue receipt thereof to the person delivering. In case of peon delivering the dak, the receipt is given by signing and stamping in the peon book.
 - c. The dak will be carefully scanned with all the attachments. (both sides, if needed)
 - d. Once the documents are scanned, the tenderer shall clean the scanned images in the best possible form so as to get a good readable quality image of the documents. Orientation of the scanned image

should also be corrected so that electronically it is easily readable. The pdf file so created should have the scanned image(s) in the correct sequence.

- e. In case the document is not of the required quality for the satisfaction of the user than the same shall be re-scanned by the tenderer at no extra cost;
- f. After scanning is carried out an e-receipt shall be created in E-office and scanned copy of the respective document shall be attached in the E-receipt. In the said Ereceipt, the Operator will have to data enter, name of the sender and subject of the dak. Thereafter, he will enter / select the recipient and electronically create and send the dak to the recipient.
- 24. Removal of the tags, all-pins, staple pins etc. as may be required for work shall be carried out by the tenderer. After completing the scanning, documents have to be restored in the original by tenderer in the original sequence duly tagged and stapled. The agency will check and scrutinize the papers to ensure no loss / mixing of papers in the dak received.
- 25. After completion of the process, the Agency will put a rubber stamp on the Face of the Dak indicating –



- 26. At the End of the day, all paper dak received and scanned will be compiled in a paper file titled "DAK Received/ Scanned on _____" (herein after referred to as day's file). MIS report of the e-receipts can be generated from the e-office application. This MIS will be printed and placed on the top of the paper file. The day's file will thereafter be page-numbered in sequential manner (by hand or by counter stamp).
- 27. The Agency operator will scrutinize the MIS report, and dak(s) placed in the day's file to ensure all the receipts (as per MIS) have been placed in the file. Page number of each dak will be manually written on the MIS sheet for easy reference. Thereafter he will carefully tag the entire-file so that no document slip out. Thereafter, this file will be handed over to the DDA's Record keeper for safe custody.
- 28. To execute the work DDA shall provide the Agency with the office space required for putting up the machinery and setting up a counter. The said office space shall be provided on As Is Where Is Basis and Agency shall not claim any other facility / amenity except for the internet and electricity connection nor shall it ever raise any claim on the said space. The Agency

shall immediately on the completion of work period or on termination / determination of the Agreement vacate the said office space without any sort of claim or demurer and shall remove all its belonging failing which the DDA shall remove the same without any notice and liability and for the purpose it may use reasonable force as well. Office space to be provided is liable to be shifted at any time and Agency shall not raise any sort of claim on that account.

- 29. DDA shall provide the tenderer with office space at concerned departments, electricity and internet connectivity only. File Covers, tags and rubber stamps will also be provided by DDA. Any other requirements for carrying out the work and day-to-day operations shall be met by the Agency itself.
- 30. Requisite hardware like computers, scanner, UPS, printer, and any other devices required for completion of task shall be provided by the tenderer. The tenderer shall also provide overhead scanner(for A3 size pages) for purpose of book/service book scanning and it shall also ensure that proper machinery is made available for scanning the pages, plans, maps etc. bigger in size.
- 31. Tenderer shall submit daily work progress report to authorized DDA official at the end of each day.
- 32. The average volume of files to be scanned is approximately 3,00,000(Three Lakh) with average 50(Fifty) pages each. Thus, total number of pages shall not exceed 1,50,00,000 (One Crore and fifty Lakhs). However, a deviation of 25% is permissible in this regard.
- ^{33.} It is estimated that out of the total volume of pages to be scanned, A3 size pages shall approximately be 3,00,000 in numbers (three lacs). A0, A1, A2 pages (collectively) shall be 50,000 in numbers (fifty thousand). Rest of the pages shall be of Letter, A4 and Legal size. A deviation of 25% is permissible in each category as well as collectively.
- ^{34.} It is clarified that quantum of work mentioned in this RFP is only indicative and approximate in number. The final number of files and pages to be scanned shall be made known only at the time of scanning. Accordingly, the agency shall prepare proper record mentioning clearly the number of files and pages scanned by it and as soon as it seems to the agency that it about to reach the approximate number of pages and files mentioned in this RFP it shall immediately notify the same in writing to the DDA preferably within 15 days in advance so that decision on giving further files and pages and any required instructions could be given to the agency in time.
- ^{35.} It is clarified that unless the aforesaid intimation in writing of scanning the aforesaid approximate number of files & pages is given by the agency, DDA shall always presume that the scope of work has not been achieved and no

extra payment shall be made for any extra work done by the agency without given intimation as aforesaid. Any post-dated intimation shall be considered under any circumstances nor shall it be binding on DDA.

- 36. Scanning of Service Books of DDA Employees : A total of 1500 service books of DDA Employees shall be scanned and converted to format supported by eHRMS software of NIC and Verification for each service book. Each service book of an employee is a hardbound booklet of 150 pages (Actual filled pages will approximately be 50).
- 37. A deviation of 25% is permissible in the total scope of work at the same rates, terms and conditions.
- 38. Care should be taken to preserve the original service booklet while creating the scan copy. Accordingly necessary scanners should be deployed. The original service book shall remain intact.
- 39. Number of Service Desk to be operationalized (minimum)
 - a. For scanning of Files and creating e-files : 2 [for 1 year]; thereafter as per requirement to cater to the workload.
 - b. For Scanning of Service Books and creating e-service Book : 2 [For 1 year]; thereafter as per requirement to cater to the workload
 - c. For scanning of dak and generating e-receipt : 4 in Vikas Sadan and 2 in Vikas Minar [for the period of contract]
- 40. The Number of Service Desk mentioned above are minimum stipulated. Depending on workload, the Agency may be required to increase the number of service desks to meet the load.
- 41. The Agency shall ensure availability of working Machines and staff for providing the services on all working days, during office hours at the premises if DDA.
- 42. Scanning Specifications
 - a. Regular Text 100 dpi Black and white (B/W)
 - b. Text with images 300 dpi greyscale
 - c. Very damaged / tarnished / clouded 450 dpi Black and white (B/W)
 - d. Documents with colour photographs 600 dpi in colour
 - e. Output format pdf
 - f. Max size for uploading complete service book 80MB
 - g. Max size for uploading part of service book 5 Mb per part (max 8 part)
- 43. The accounts department Receives, on a daily basis, from the Banks (in which citizen make payments to DDA through Challans), Challans deposited in the day along with a Bank scroll of such Challans.

- ^{44.} The Accounts department will provide to the agency, challans and scrolls in physical forms related to the payments done by general public for flats, plots etc. on a daily basis.
- 45. The Data Entry Agency will be required to data-enter
 - a. The Bank Scroll for the day; and thereafter
 - b. Each of the challan accompanied with the Bank Scroll.

The Formats of the Bank Scrolls and the Challans are in Data Sheet 6. Data Entry screen/ format also provided in Datasheet 6. (This screen can be re-formatted in consultation with the Data Entry Agency for the ease / convenience of the operator).

- 46. After entering the challan details and scroll details, the online application will detect the discrepancy, if any (between the scroll and the challans entered). In case some discrepancy is due to data entry error, such error of data-entry will be corrected by the Supervisor of the Agency. In case discrepancy is at the level of bank (and not because of data-entry) it will be brought in the notice of accounts department through the application itself and in such case no correction in bank data will be made. In nutshell the agency is required to correct data entry errors only.
- 47. This is a sensitive job and utmost care will have to be taken while entering this data and 100% accuracy in this case is required.
- ^{48.} In general, for all above stated scanning work, the service provider will have to provide the scanned data in a storable and easily retrievable form.
 - a. The data should be indexed for easy search and retrievable.
 - The format in which the data is to be provided should be in pdf or any other user/application specific format as per the need of concerned department of DDA.

Milestones* and Terms of Payment to the Selected Agency

Payment Terms

- 1. The tenderer shall be paid for the services rendered on completion of satisfactory services for each quarter i.e. payments shall be back ended to delivery of the work done. Payment shall be made as per actual work done.
- 2. The Daily reports submitted by the Agency of work performed [and records scanned] will form the basis of calculation of payments due to the agency.
- 3. DDA will appoint Nodal officers to verify/ authenticate the daily report of the quantum of work performed. The work performed by the agency in terms of treating satisfactory services, should, on daily basis be verified and authenticated by the Nodal Officer. This report of quantum of work should match with the MIS report of E-Office and E-HRMS.
- 4. The Agency should submit quarterly bill of services performed and payment will be made on quarterly basis for actual work done only.
- 5. In case, it is decided by the Nodal Officer that any particular Counter(s) is(are) to be closed, The Agency will stop operations of that(those) counter(s) within 10 days of such order by the Nodal officer. On the other hand, if the Nodal Officer decides that new counter(s) is(are) required to be opened, the Agency will make necessary arrangements to open the new counter in 10 days of such order.

*Priority and timelines for achieving mile-stones for scanning and other work related with this tender should be looked after by the user department in collaboration with the agency.

SLA > Data Sheet 5:- PENALTIES

- Non-Availability: In case of failure to establish / operationalize the minimum number of service desk as specified in this tender, a penalty of Rs 2,000 per day per service-desk will be levied and deducted (Subject to Maximum of Rs 2,00,000 per quarter) from the payment due. However, if in a quarter, total down-time is less than 10 ServiceDesk – days, no penalty shall be levied.
- 2) Delay: The pendency of dak in the R&I desk should not be more than 1 working day.(e.g. Dak received on 13th should be scanned, uploaded and eforwarded by 14th). In case of delay in scanning and uploading of dak is more than 1 day, a penalty of Rs 10/- per dak per day of delay will be levied (and deducted from the payment due), subject to a maximum of Rs 20,000 per quarter. However, in a quarter, if the total dak-delay is less than 200 dak-days, no penalty shall be levied.
- 3) Defect / Deficiency : In case of any defect / deficiency in service, DDA Nodal officer will serve a notice by e-mail to the Project Nodal officer of the agency, and the Agency shall, to the best of its capacity, rectify the defects and deficiencies at no additional costs to DDA. In case of failure to rectify the defects, a penalty of Rs 1000 per case shall be levied.
- 4) Loss of Records / Files : In case the agency looses any record / file / paper / service book, a penalty of Rs 10,000 per such loss (in case of file / service book) or Rs 100 per page (in case of loss of papers) will be levied. Further, in case any malafide is detected (that the loss of paper / file causes loss to DDA or leads to corruption / malpractice), DDA may terminate the contract forthwith and forfeit the performance guarantee.
- 5) Data entry errors : DDA will conduct 5% random check / verification of Service book record data-entry work. In addition, as per e-HRMS application, each employee is expected to point-out if any errors have been recorded in his eService book. In case any data entry error is detected/reported by an employee in digitization of service book, the agency will rectify the data free of cost. In addition, for each data-entry error detected, a penalty of 1.5 times the payment due for data entry work of one service book will be deducted. However no penalty will be imposed if, overall data entry error is less than 0.1% of the total dataentries in the quarter.
- 6) For Data Entry of Challans and Scroll the 100% correctness is required. In case of any error, it has to be corrected on the same day failing which a penalty of Rs 1000 per challan shall be imposed per error and if it will be found that error was intentional with the motive of ill intention then criminal case may also be registered.

- 7) In case the tenderer fails to adhere to the time frame for starting the work as per the schedule, they shall pay as liquidated Damages and not by way of penalty, the Selected bidder shall pay to the DDA, damages in an amount calculated at the rate of 0.5% (zero point five per cent) of the Performance Bank Guarantee for each week (part of a week being treated as a full week) of delay, up to a maximum deduction of 10% (Ten percent) of the total contract price until the fulfilment of such conditions precedent. The decision of the DDA shall be final and binding unless reasonable grounds are shown in writing during the weekly review meetings.
- 8) In case the performance of the tenderer is not found satisfactory during the period of project, Performance Bank Guarantee will be invoked by DDA. Competent Authority in DDA shall have the right to invoke Performance Bank Guarantee at any time. The tenderer shall have no claim for any compensation or any loss on this account.

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender / Bid documents an d Contract between the parties,

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

Article 1: Commitment of the Principal / Owner

- (1) The Principal / Owner commit s itself to take all measures necessary to pr event corruption and to observe the following principles:
- a) No employee of the Principal / Owner, personally or through any of his/ her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitle d to.

- (2) If the Principal / Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC) / Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned of if there be a substantive suspicion in this regard, the Principal / Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: commitment of the Bidder(s) / Contractor(s)

(1) It is required that each Bidder / Contractor (including their respective officers, employees and age nts) adhere to the highest ethical standards, and report to the Government / Department all suspected act s of fraud or corruption or Coe rcion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.

If the Bidder(s) / Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any oth er form, such as to put his reliability or credibility in question, the Principal / Owner after giving 14 days' notice to the contractor sha ll have powers to disqualify the Bidder(s) / Contractor(s) from the Tender process or terminate/ determine the Contra ct, if already executed or exclude the Bidder / Contractor form future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be f orever or for a limited period as decided by the Principal / Owner.

2.  - within seven (7) days, if the Agency, in the judgment of the DDA has engaged in Corrupt or Fraudulent Practices i n competing for or in executing the Work order;
 - if the DDA, in its sole discretion and for any reason whatsoever, within a period of fifteen (15) days' decides to terminate this Work order.
- 42) Subject to this agreement, any functionality which is neither in the tender document nor explicitly specified in the scope of work, if considered to be a breach of contract, such that the Agency must be liable for legal actions and be charged for damages.
- ⁴³⁾ DDA may, at any time, terminate the purchase order by giving four weeks written notice to the Agency, without any compensation to the Agency, if the Agency becomes bankrupt or otherwise insolvent.

- ⁴⁴⁾ Payment upon termination: Upon termination of this Work order, the DDA will make the following payments to the Agency:
 - a) Remuneration pursuant to relevant clauses for Services satisfactorily performed prior to the effective date of termination;
 - b) Upon termination, the DDA may also impose liquidated damages as per the provisions of relevant clauses of this Work order.
 - c) The Agency will be required to pay any such liquidated damages to DDA within 30 days of termination date.

Severability:

⁴⁵⁾ If for any reason whatever any provision of the Work order is or becomes invalid, illegal or unenforceable or is declared by any court of competent jurisdiction or any other instrumentality to be invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions shall not be affected in any manner, and the Parties will negotiate in good faith with a view to agreeing upon one or more provisions which may be substituted for such in valid, unenforceable or illegal provisio ns, as nearly as is practicable. Provided failure to agree upon any such provisions shall not be subject to dispute resolution under the Work order or otherwise.

Risk Purchase

- ⁴⁶⁾ In the event Agency fails to execute the project as stipulated in the delivery schedule, or to the satisfaction of the DDA or fails to perform its obligations (or any part thereof) under this Agreement or if the Agreement is terminated by the DDA due to breach of any obligations of the Agency under this Agreement, DDA reserves the right to procure similar or equivalent Services/ Deliverables from another alternate source at the risk, cost and responsibility of the Agency.
- ⁴⁷⁾ Any incremental cost borne by the DDA in procuring such Services/ Deliverables shall be borne by the Agency. Any such incremental cost incurred in the procurement of such Services/ Deliverables from alternative source will be recovered from the undisputed pending due and payable payments, Security Deposit/ Bank Guarantee provided by the Agency under this Agreement, and if the value of the Services/ Deliverables under risk purchase exceeds the amount of Security Deposit/Bank Guarantee, the same may be recovered if necessary by due legal process. Before taking such a decision under this Clause, DDA shall serve a notice period of 1(one) month to the Agency.

Limitation of Liability

- 48) Neither the Party shall be liable to the other Party for any indirect or consequential loss or damage(including loss of revenue and profits) arising out of or relating to the Contract.
- ⁴⁹⁾ Except in the case of Gross Negligence or Wilful Misconduct on the part of the Agency or on the part of any person acting on behalf of the Agency executing the work or in carrying out th e Services, the Agency, with

respect to damage caused by the Agency including to property and/ or assets of DDA or its clients shall regardless of anything contained herein, not be liable for any direct loss or dama ge that exceeds (A) the Contract Value or (B) the proceeds the Agency may be entitled to receive from any insurance maintained by the Agency to cover such a liability, whichever of (A) or (B) is higher.

- ⁵⁰⁾ This limitation of liability slated in this Clause, shall not affect the Agency's liability, i f any, for direct damage by Agency to a Third Party's real property, tangible personal property or bodily injury or death caused by the Agency or any person acting on behalf of the Agency in executing the work or in carrying out the Services.
- 51) The Agency shall always indemnify the DDA for all types of losses, damages and accidents etc.
- ⁵²⁾ DDA shall never be held responsible for any type of loss or damage which may cause to Agency's employees, workers, labour, staff, technicians, agents, assigns, visitors etc., due to any reason, whatsoever.
- 53) For the purposes of above Clauses, -
 - (i) "Gross Negligence" means any act or failure to act by a Party which was in reckless disregard of or gross indifference to the obligations of the Party under the Contract and which causes harmful consequences to life, personal safe ty or real property of the other Party which such Party knew, or would have known if it was acting as a reasonable person, would result from such act or failure to act. Notwithstanding the foregoing, Gross Negligence shall not include any action taken in good faith for the safeguard of life or property.
 - (ii) "Wilful Misconduct" means an intentional disregard of any provision of this Contract which a Party knew or should have known if it was acting as a reasonable person, would result in harmful consequences to life, personal safety or real property of the other Party but shall not include any error of judgment or mistake made in good faith.

Indemnity

- ⁵⁴⁾ The Agency must indemnify the DDA against all third party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied software/ hardware/ manpower etc and related services or any part thereof. DDA stand indemnified from any claims that the hired manpower / Agency's manpower may opt to have towards the discha rge of their duties in the fulfilment of the purchase orders. DDA also stand indemnified from any compensation arising out of accidental loss of life or injury sustained by the hired manpower / Agency's manpower while discharging their duty towards fulfilm ent of the purchase orders.
- ⁵⁵⁾ The Agency agrees to indemnify and hold harmless the DDA from and against any and all claims, actions, proceedings, lawsuits, demands, losses, liabilities, damages, fines or expenses (including interest, penalties, attorneys fee s and other costs of defense or investigation related to or arising out of, whether directly or indirectly,

- a) the breach by the Agency of any obligations specified in relevant clauses hereof;

Settlement of disputes and Arbitration

- 65) If the Agency doesn't agree with the opinion of the Vice -Chairman DDA, the matter shall be decided through the process of Arbitration and shall, acoordingly, be referred to a panel of three Arbitrators. For the purpose of appointment of Arbitrators, the Agency shall issue a notice invoking the Arbitration clause, whereupon, the DDA shall within a period of a thirty days of the receipt of the said notice, propose name of s even persons out of whom one shall be nominated by the Agency and, thereafter, one shall, be nominated by the DDA and the said two nominated arbitrators shall choose the presiding arbitrators from the said list itself. The award of the Arbitrators shall be final and binding on the parties. Proceedings u nder this clause shall be subject to applicable law of the Arbitration and Conciliation Act, 1996 and the Rules framed by the Delhi Arbitration Centre, venue of such arbitration shall be Delhi. Cost of arbitration shall be borne by each party proportionately, as perthe Schedule IV of the Arbitration and Conciliation Act, 1996 as amended upto date. However, expenses incurred by each party in connection with the preparation, presentation shall be borne by the party itself. The provisions of this clause shall survive termination of this Agreement. It is an agreed term of this clause that only those claims and disputes shall be referred to Arbitration which are mentioned in the aforesaid notice and no new issue or clam shall be entertained by the Arbitrators. Also any decision or provision of the Agreement / RFP made final and binding shall be beyond the scope of RFP

Notices

(i)

- 66) Unless otherwise stated, notices to be given under the Work order including but not limited to a not ice of waiver of any term, breach of any term of the Work order and termination of the Work order, shall be in writing and shall be given either by –
 - e-mail at the email address mentioned in this agreement or,
 - through any physical mode (such as hand delivery, recognized international courier) and transmitted or delivered to the Parties at their respective addresses.

67) The notices shall be deemed to have been made or delivered -

(iii) in the case of any communication made by email, when transmitted properly addressed to such e-mail address, and

(iv) in the case of any communication made by letter, when delivered by hand, by recognized international courier or by ma il (registered, return receipt requested) at that address.

Intellectual Property Rights

- ⁶⁸⁾ In case of development of the application: Agency shall disclose all such Intellectual Property Rights arising in performance of the Services to the DDA and execute all such agreements/documents and file all relevant applications, effect transfers and obtain all permits and approvals as may be necessary as per the existing laws in India to effectively transfer such rights to the DDA. All documentation and configuration items such as scripts, code, queries etc. developed by the Agency shall be property of the DDA. The Agency should create a repository of such resources and provide access to DDA. The Agency undertakes to disclose all such Intellectual Property Rights arising in performance of the Services to the DDA and execute all such agreements/ documents and file all relevant applications, effect transfers and obtain all permits and approvals that may be necessary in this regard to effectively transfer and conserve the Intellectual Property Rights of the DDA: -
 - (a) Agency shall not only support DDA with the proposed COTS during the contract period, but also, confirm that after the expiration / termination of the initial contract, continued support will be provided by the Agency to the DDA, in case DDA chooses to maintain / upgrade the COTS proposed, either directly or through third party agency(ies);

In case of any infringement by the Agency / Agency's Team, Agency shall have sole control of the defense and all related settlement negotiations.

The Agency also represents warrants and covenants that the medium on which the Software is contained when delivered to the DDA, will be free from defects in material or workmanship, and shall be free from any viruses, bugs etc.
- ⁷⁴⁾ The Agency represents warrants and covenants that the Technical Documentation delivered to the DDA for the system developed and operationalised will be sufficient to allow a reasonably knowledgeable information technology professional to maintain and support such Software. Publicity

Performance Security

- 76) In the event where due extension of work order orotherwise, validity of Performance Bank Guarantee is near its expiry, the Agency shall at least fifteen (15) days prior to the commencement of every Subsequent Year or at least thirty (30) days prior to the date of expiry of the then existing bank guarantee, whichever is earlier, provide a fresh unconditional and irrevocable bank guarantee as Performance Security for the same amount as existing Bank Gurantee, or The Performance Security shall be extended accordingly such that the Performance Security remains valid until the expiry of a period of 60 (Sixty) Days from the date of completion of the assignment.
