a. Indoor Sports Facilities now available









b. Commencement of Yoga Sessions


DDA TAKES NECESSARY MEASURES TO ENSURE TIMELY HAND-OVER OF DWARKA FLATS

After receiving enthusiastic response for Dwarka Golf view apartments, DDA is now working on war footing to meet the deadline of finishing the project by end of June 2024.

The work force for the project is to be increased by nearly 50 percent and one nodal officer of the rank of Assistant Engineer has also been deputed for each tower to closely monitor the progress and quality of work.

Shri Subhasish Panda, Vice Chairman DDA is personally monitoring the project on daily basis and has visited the project site on 25.04.2024 to take stock of the development work.

The DDA has for the first time entered into luxury segment with the Festival Housing Scheme, which was launched on 30.11.2023.







The flats-Penthouses, Super HIG and HIG, in Dwarka Sector 19B were offered through an auction mode, under which buyers had the option of choosing the flat of his/her choice by paying the bidding amount.

The scheme received great response and all 14 penthouses and 170 super HIG flats offered in the scheme were completely sold out. Besides, 940 HIG flats were also booked. DDA also provided facility of sample flats so that buyers can take informed decision before purchasing the flats. Besides, help desk and housing camps were also organised to address queries of the prospective buyers.
