DDA ALLOTS FLATS TO JJ DWELLERS, JAILORWALA BAGH

In line with the vision of Hon'ble Prime Minister and under the guidance of Hon'ble Lt Governor, Delhi to provide Housing for All, DDA allotted 1078 EWS flats to the eligible families of JJ Cluster, Jailorwala Bagh, Ashok Vihar under In-Situ Slum Rehabilitation Project.

Demand-cum-allotment letters have been issued on 27.06.2023.

Under the directions of Hon'ble Lt Governor, a facilitation centre has been set up by DDA, which is adjacent to the JJ cluster to avoid inconvenience to the JJ dwellers. Facilities like distribution of Demand-cum-Allotment Letters, obtaining biometric, facility of provision of loan by financial institution to desirous allottees, preparation & submission of documents for possession and issue of possession letters will be available at the centre

The facilitation centre was inaugurated on 06.07.2023 by Dr. Harsh Vardhan, Hon'ble Member of Parliament in the presence of JJ Dwellers. The JJ dwellers were also apprised of the facilities available in the centre and were requested to timely complete the formalities for issue of possession letters.

AMALGAMATION OF FLATS UNDER DDA'S FCFS HOUSING SCHEME 2023 PHASE-IV

If an applicant happens to buy two adjacent flats in offer in this scheme of FCFS Phase IV, he has the liberty of amalgamating the two by opening a common door through the common wall between them, subject to necessary structural approvals.

This is applicable to all localities and all types of flats. If one applicant happens to buy an adjacent flat to a flat which he already owns from earlier scheme, principles of amalgamation will also be applicable.

Delhi Development Authority has launched Housing Scheme on First Come First Serve basis for over 5500 flats across all categories at various locations of the national capital on June 30, 2023.

Under the scheme, 1BHK flats are offered in Narela, Siraspur, Rohini, Lok nayak Puram; 2BHK are offered in Narela and Dwarka while 3 BHK in Jasola. The booking of flats will be available from 10.07.2023 from 12 PM.

The scheme is receiving good response from the general public and around 4000 registrations have been made so far.

DDA'S FCFS HOUSING SCHEME: DWARKA FLATS SOLD OUT, HEAVY DEMAND FOR NARELA & ROHINI

DDA's First Come First Serve scheme receiving overwhelming response with Dwarka 2BHK flats being completely sold out within few hours of booking opening, and Narela, Rohini receiving heavy demand from the public.

The booking opened on 10.07.2023 at 12 PM and within few hours over 650 flats booked and it is still continuing at brisk pace.

Under the constant guidance of Hon'ble Lt Governor, the FCFS scheme of DDA continues to get overwhelming response from the home buyers, with over 1000 flats booked across various locations of the national capital.


In an unprecedented step, DDA for the first time in its history, has issued 945 demand letters online to all those who have booked the flats in the last 24 hours.

Meanwhile, DMRC has issued a statement saying that the proposed Rithala - Narela corridor of the Delhi Metro Rail Corporation (DMRC) may possibly be extended up to Kundli in Haryana.

DDA ORGANIZES MEGA CAMP AT NARELA FOR FCFS HOUSING SCHEME 2023

Delhi Development Authority (DDA) is committed to fulfilling the vision of our Hon'ble Prime Minister, and operates under the consistent guidance of the Hon'ble Lt. Governor, Delhi. To provide affordable housing options to the citizens of Delhi and to ensure ease of participation for the general public in the First-Come-First-Serve (FCFS) Scheme Phase IV, DDA organized a Mega Camp at Narela for the Housing Scheme 2023.



Mega Camp was held on July 8 and 9, 2023, from 10 a.m. to 6 p.m. at the Community Hall in Pocket 1C, Sector A1-A4, Narela.

This camp aimed to provide extensive support to the general public by DDA officials regarding registration in the scheme on-the-spot, site and flat visits, as well as addressing any queries/issues/doubts they may have. Additionally, bank/NBFC representatives were available to assist the public with loan arrangements and related queries.

The Nodal Officers facilitated visits to the designated sites, allowing interested individuals to view the flats. Sample flats were prepared for public viewing, enabling potential buyers to make informed decisions.

Transportation facilities from Jahangirpuri Metro station to the Mega Camp site and back were also made available by DDA.

Besides the camp, DDA officials, along with the necessary infrastructure of computer systems, is stationed at Narela from July 5, 2023. These officials will guide and assist interested persons who may require help in completing their registration for the scheme.

Furthermore, the Housing Department has made their staff available at the Nagrik Suvidha Kendra in the Head Office at Vikas Sadan, INA. They will be present to aid interested individuals in filling up the registration form and providing clarification on any queries they may have.
