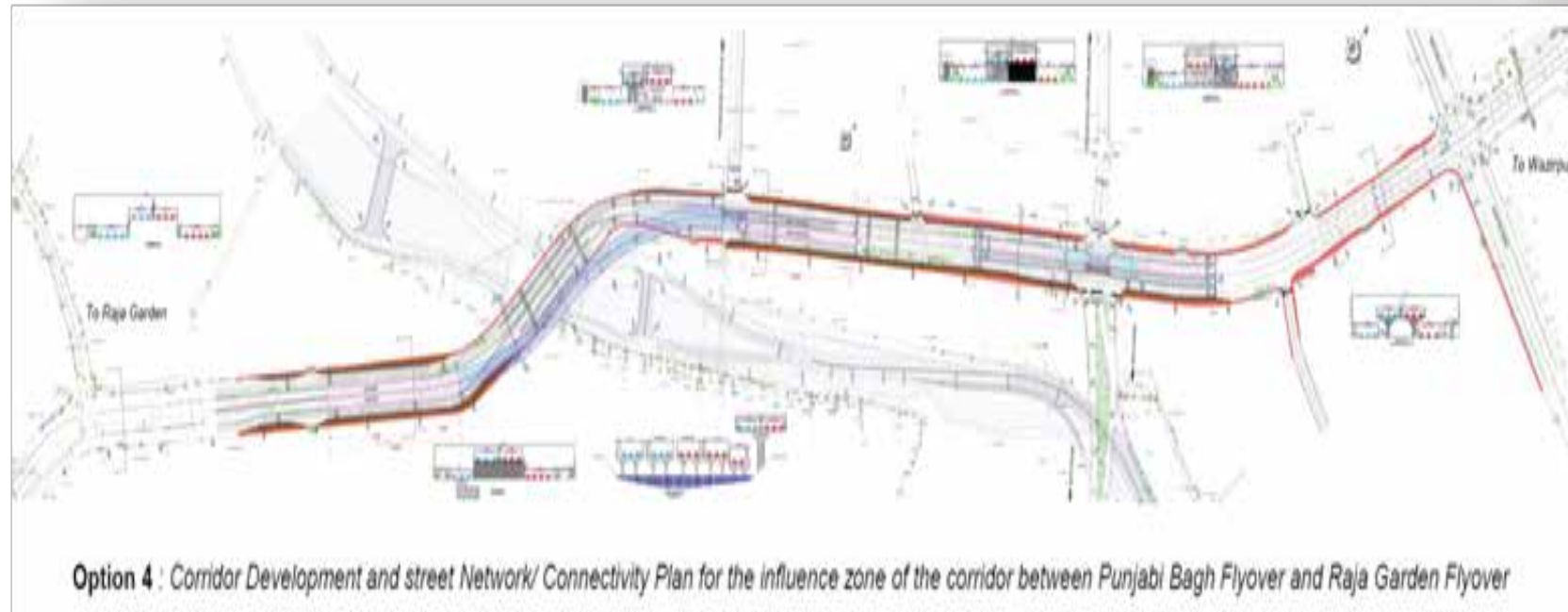

61st Meeting of Governing Body of UTTIPEC

Following proposals were discussed/considered in the 61st meeting of Governing Body of UTTIPEC under the Chairmanship of Hon'ble Lt. Governor, Delhi on 24.12.2020:

1. Corridor Development and Street Network/ Connectivity Plan for the influence zone of the corridor between Punjabi Bagh Flyover and Raja Garden Flyover.

The corridor starts from Raja Garden flyover to Punjabi Bagh flyover, and is a part of Ring Road in North-West Delhi. The proposal includes provision of three lanes – dual carriage way grade separator from Raja Garden Crossing over the Club Road intersection along with doubling the existing flyover over the Punjabi Bagh Crossing (Moti Nagar Crossing).

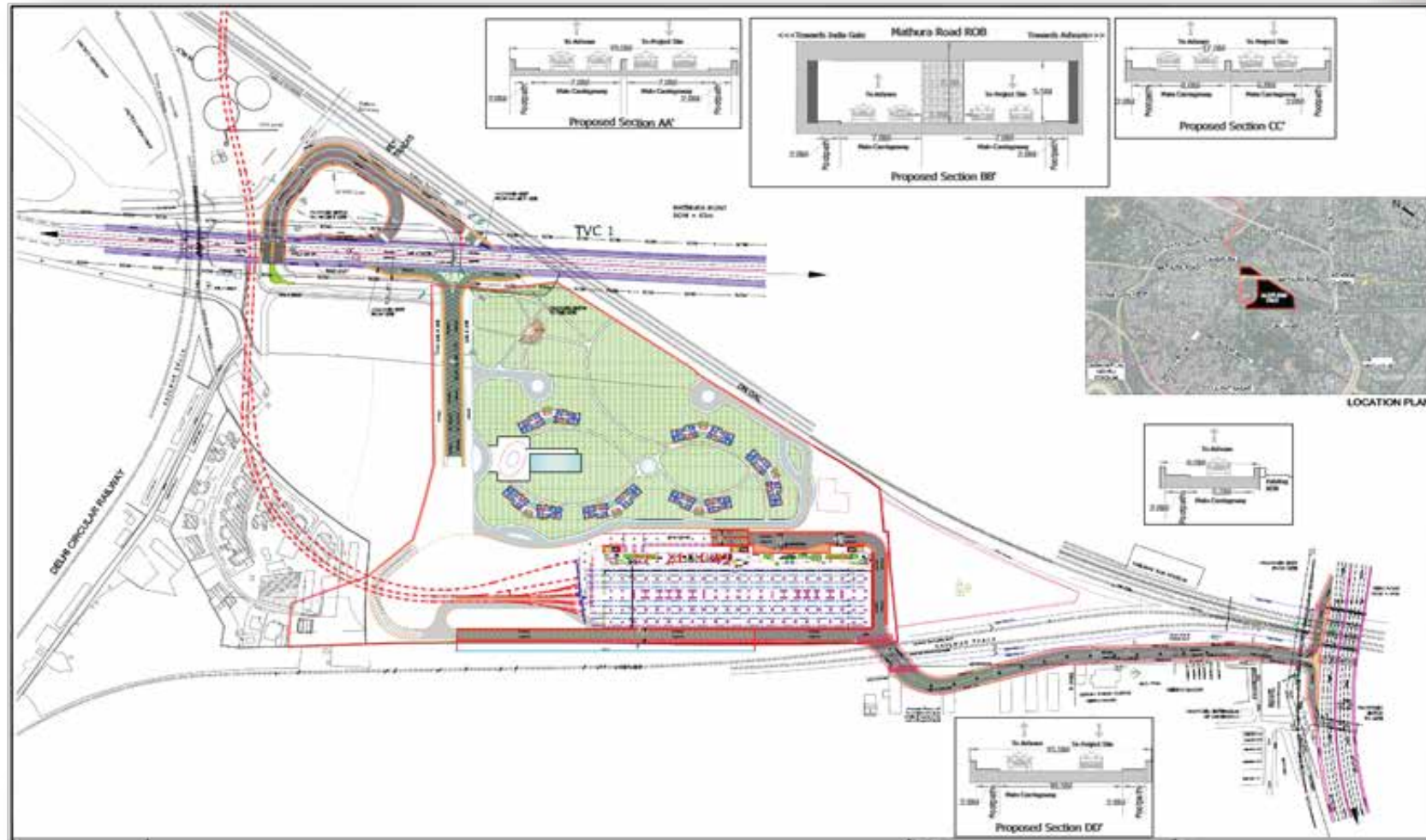
The PWD proposal will decongest the Ring Road and improve its capacity. It will help to provide signal free movement from DhaulaKuan to Azadpur on the Ring Road.

The Governing Body of UTTIPEC approved the proposal, with the condition to incorporate the provisions for adequate space for safe movement of pedestrian in this stretch.

2. Traffic Study and proposal for Hindustan Prefab Ltd (HPL) site at Jangpura (RRTS Stabling Line) for road connectivity of proposed RRTS complex at Jangpura, New Delhi.

National Capital Region Transport Corporation (NCRTC) has planned to accommodate the Operation Control Center, Service buildings, and essential staff quarters along with other required installations of Rapid Rail Transit System (RRTS) at Jangpura.

This land is bounded by three railway tracks forming a triangle and has a very poor connectivity with adjacent roads. Connectivity has been proposed through

provision of trumpet towards Mathura Road; which will be 4 lane divided with 2 m footpath on both sides, and a 2 lane undivided Flyover with 2m wide footpath on both sides (along the Railway line) towards Ring Road.

The Governing Body of UTTIPEC approved the proposal.

3. Detailed Feasibility Study and geometric design for construction of ROB/RUB on Railway Crossing No. LC-12 (Delhi-Ambala line) on Khera Kalan to KheraKhurd Road.

PWD has proposed the construction of Road OverBridge (ROB) and Road Under Bridge (RUB) on Railway Crossing No.LC-12 (Delhi-Ambala line) on Khera Kalan to KheraKhurd Road. The ROB is proposed for efficient movement of through traffic whereas the RUB is proposed to segregate the through traffic from the local traffic of Khera Kalan and KheraKhurd.

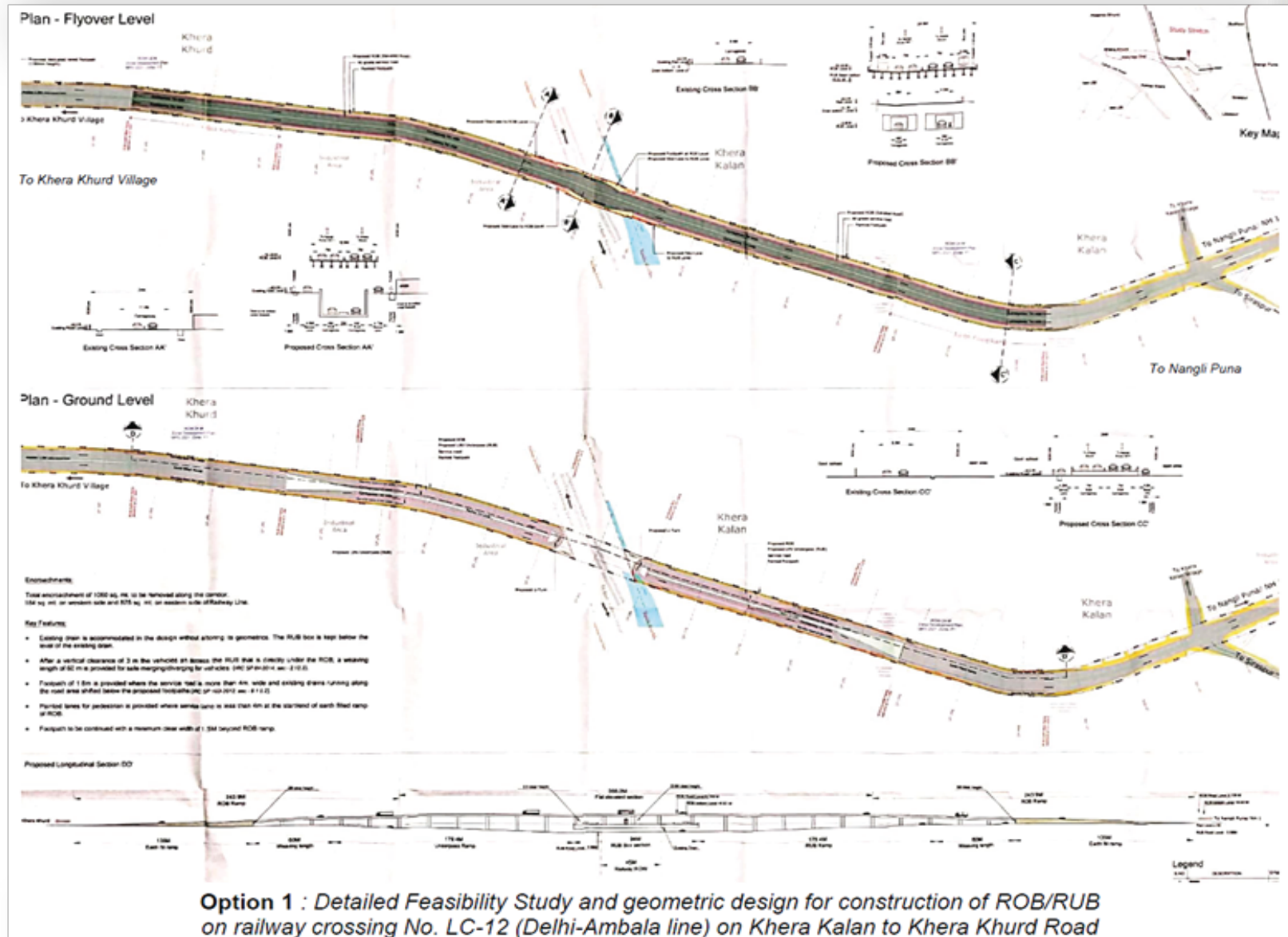
At present, vehicles create a long queue at the at-grade railway crossing, resulting in traffic congestion. The proposal will provide uninterrupted movement across the Delhi-Ambala Railway line at Railway Crossing No. LC-12.

Inauguration Of Redeveloped Back Nine Holes and New Driving Range At Qutab Golf Course

DDA has developed 15 sports complexes, 03 mini sports complexes, 15 swimming pools, 26 multi gyms in green areas and several play fields and fitness trails across the city. DDA developed the first public golf course in India, Qutab Golf Course (QGC), which was inaugurated on 02nd January, 2000. The Qutab Golf Course (QGC) has become a popular destination for the golfing community of Delhi and NCR and has popularized the game in the city.

Redevelopment of Qutab Golf Course (QGC) started in 2016 and after completion of the redevelopment of Phase-I of the course, the front 09 holes of the course were inaugurated by Shri Anil Bajjal, Hon'ble Lt. Governor, Delhi on 7th October, 2018. The new Club House at the golf course was also inaugurated by Hon'ble Lt. Governor on 24th February, 2019. Club house has been designed in-house by DDA's Architecture Department.

After completion of the redevelopment of Phase-II of the Qutab Golf Course (QGC), the back 09 holes of the course were inaugurated by Shri Anil Bajjal, Hon'ble Lt. Governor, Delhi on Saturday, 5th December, 2020 in the presence of Shri Anurag Jain, Vice Chairman, DDA. A state-of-the-art Driving Range which

has been newly constructed was also inaugurated by Shri Anil Baijal, Hon'ble Lt. Governor, Delhi on 5th December, 2020. The double level Driving Range has 28 bays along with a number of other facilities like, simulator room, teaching room, fitting room, pro shop, coffee shop, etc. The range is floodlit and also has an artificial turf putting arena.

DDA has also developed a 09 hole public golf course at Bhalswa. Work has been awarded for a championship level golf course with yardage of over 7100 yards at Sector-24, Dwarka. Work has also commenced on development of several Centres of Excellence and new sports complexes at Dwarka and Rohini.





58th Special Task Force Meeting

The 58th meeting of STF was held on 11.12.2020 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 30th November was reviewed.

In total 67,847 complaints have been received in STF till 30th November 2020 and action on 61,658 complaints has been initiated. 882 ATR were received during the period from 16.11.2020 to 30.11.2020. Since the constitution of STF in 2018, more than 3000 unauthorised constructions have been demolished and more than 2100 properties have been sealed. Other kind of actions have also been taken up with concerned agencies such as DJB, Electricity, Revenue which comes to more than 2400. In addition to this, more than 7500 active actions have been taken up by the ULBs on unauthorised constructions.

Chairman, STF directed the ULBs to expedite the action on the pending cases.

SDMC has taken demolition action on unauthorised constructions in Shaheen Bagh, Saidul Ajaib, and Madangir. Removal of encroachment done by SDMC at areas including Malviya Nagar, RPS Colony, Khanpur and in Car Market near Ambience Tower and surrounding areas.

Anti-encroachment drive was carried out by NDMC at properties in areas including Shanker Market, Regal, Bengali Market, Janpath, Bangla Sahib Road,

Gole Market, Safdarjung, AIIMS, Delhi Haat INA Metro Station, Khanna Market, VIP Area, Sarojini Nagar & Chanakyapuri, Rajiv Chowk and Palika Bazar.

Demolition and Sealing Action taken by EDMC in Shastri Park. Regarding removal of the encroachment from 54 Tot lots in Pkt.1 Mayur Vihar Phase-I, EDMC has informed that as per the court direction, Gates are remodelled with ramps to be accessed by differently abled persons. The total work will be completed within a month. Anti-encroachment drives have also been initiated on approximately 197.1 km road length by ULBs between 16th November and 30th November 2020. North DMC has cleared 46.9 km, SDMC 79.2 km, EDMC 47 km and NDMC 24 km.

Chairman, STF re-iterated that close co-ordinated efforts need to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Police Deptt. assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.

59th Special Task Force Meeting

The 59th meeting of STF was held on 31.12.2020 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 15th December was reviewed.

In total 69,543 complaints have been received in STF till 15th December 2020 and action on 63,600 complaints has been initiated. 1942 ATR were received during the period from 01.12.2020 to 15.12.2020. Since the constitution of STF in 2018, more than 3000 unauthorised constructions have been demolished and more than 2100 properties have been sealed. Other kind of actions have also been taken up with concerned agencies such as DJB, Electricity, Revenue which comes to more than 2500. In addition to this, more than 7500 active actions have been taken up by the ULBs on unauthorised constructions.

Chairman, STF directed the ULBs to expedite the action on the pending cases.

During 1.12.2020 to 15.12.2020, Anti-Encroachment drive was carried out by NDMC in Connaught Place, Palika Bazar, Gole Market, Janpath, Regal and Rivoli and Shanker Market, Safdarjung, Sarojini Nagar, Chanakyapuri area and VIP area.

Encroachment Removal Action taken by SDMC at areas including Khanpur, Pipalwala Chowk, MB Road, Green Park Main, DDA Market, Okhla Phase - 2, Harkesh Nagar metro station and surrounding areas, Meher Chand mkt, CGO

complex and surrounding areas, Guru Ravidas Marg and surrounding areas, at N.F.C Market, Mata Mandir road, Sukhdevvihar and Vasant Vihar.

Demolition of unauthorised construction was carried out by North DMC at properties in areas including Mansarovar Garden in Karol Bagh Zone, Baba Fareed Puri, Mansarovar Garden and JwalaHeri Village in Paschim Vihar.

Demolition of unauthorised construction was carried out by EDMC at properties in areas including Mayur Vihar Ph-III, Gagan Vihar, Gajju Katra, Shahdara, Shastri Park, Balbir Nagar and Moti Ram Road. An anti-encroachment drive was also carried out in East Laxmi Nagar by EDMC.

Chairman, STF re-iterated that close co-ordinated efforts need to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Police Deptt. assured that all support shall be provided to remove the encroachment from roads and take action on unauthorised construction effectively.

DDA Land Pooling Scheme : Be-aware of fraudulent schemes

The Economic Offence Wing has recently registered cases against some developers and promoters for luring and misleading people into fictitious housing schemes under the garb of Land Policy. DDA has time and again cautioned home buyers or investors against fraudulent practices by some developers or societies to lure people into buying houses under the false pretext of DDA's land policy. For more information, public is urged and advised to visit DDA's website or various notices at <https://online.dda.org.in/landpooling/AppForm/Default.aspx>. Any person interested or being given promise of any land or apartments under any Land Pooling Scheme must go through the instructions and details about the DDA's Land Pooling Policy so as to safeguard public interest and avoid any trap by fraudsters floating or advertising false and fictitious Land Pooling Schemes.

For the benefit of general public, it is informed that DDA at present is inviting online applications from the landowners for expressing willingness to participate in the Land Pooling Scheme in K-I, L, N, P-II and J Zones falling in 95 urbanized villages having 109 Sectors. A Sector would qualify for next step of implementation of scheme, if minimum 70% contiguous land is made available through pooling and all the landowners form a Consortium on issue of notice by DDA. The consortium as a single entity shall then apply to DDA for further planning of the pooled land and earmarking the land retained by the consortium

for its development. The implementation of land policy shall be done as per Land Policy, 2018 incorporated as Chapter 19 in the Master Plan of Delhi-2021 and its Regulations, notified in 2018. The key stages to be followed by Consortium or Developer Entity (DE) for undertaking development under the Land Policy 2018 are uploaded on DDA's Land Pooling Web-portal.

Once the sector becomes eligible as per the notified Land Policy or Regulations, Consortium shall apply for the Provisional Development License (PDL) indicating details of final developable plot retained by the Consortium or DE in the sector. Thereafter, the consortium or DE can take up development on the final identified land as per the Final Development License (FDL) issued by DDA.

Till date DDA has neither issued any license or approval to any housing project in any Zone or Sector under its Land Policy nor authorized any developer or builder or society or company to offer any flat under the Land Policy. It is illegal to advertise or market or book or sell or invite persons to purchase any plot or flat in any project without registration or approval of the project under Real Estate Regulatory Authority Act (RERA)- 2016.

Home buyers or investors are advised to check for RERA registration of projects for NCT of Delhi and also to check if FDL is issued by DDA to the developer before investing in the name of DDA's Land Pooling Scheme. DDA has also been

providing information from time to time to the ongoing investigation by Economic Offences Wing of Delhi Police in response to various complaints made by general public against builders or housing societies or developers in relation to housing schemes under the name of land policy.

DDA is again requesting the aggrieved persons, who have invested in the name of fraudulent Land pooling schemes launched by developer/societies etc., to approach Delhi Police Economic Offence Wing and file formal complaints against the fraudsters.

- In all cases of disposal of properties through E-Auction (Land Disposal), where demand letter was issued for 75% of bid amount before 01.10.2019 and full payment have been made with respect to premium of the property/plot by 01.11.2020, as a one-time relief measure, the delay period, if any, has been treated as automatically regularized post facto (with applicable interest).
