- Before submitting a tender, the tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the works, that all conditions liable to be encountered during the execution of the works are into account and that the rates he enters in the tender forms are adequate and all inclusive to accord with the all the provisions of the Standard/ General Conditions /Clauses of Contract/bid document for the completion of works to the entire satisfaction of the Engineer.
- ii) Every tenderer/bidder is required to be registered compulsorily himself under GST Act.
- 12. The intending bidder must have class-III digital signature to submit the bid.

14. The intending bidder must read the terms and conditions of PWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
