

OFFER OF DDA COMMUNITY HALLS AND VACANT LAND FOR COVID MITIGATION PURPOSES

(A) Delhi Development Authority (DDA) is managing Community Halls (along with open spaces adjoining Community Halls), which are normally available to public for marriage / social functions.

With a view to support organisations / RWA to manage / the combat COVID pandemic in the City, DDA proposes toferoffer such Community Halls on license basis, for a maximum period of six months, to be utilized for COVID management infrastructure.

The List of Community Halls on offer, and terms and conditions for allotment including License Fee etc. are available on DDA website.

Interested Organisations, RWAs etc. willing to take DDA Community Halls on License for setting up COVID related facilities may apply in prescribed format (available on DDA website), along with the Security, to the concerned SE(HQ) of the Zone in which the said Community Hall falls.





- (B) DDA is also considering proposals for Allotment of vacant Land on temporary License basis (max. 6 months) to Hospitals / Charitable institutions for establishment of additional COVID facilities / Oxygen Plants and other ancillary facilities for combating COVID pandemic.
 - The Policy for such allotment on temporary basis, terms and conditions of allotment, prescribed format for application including the License Fee etc. are available on DDA website.
 - Hospitals / Charitable institutions seeking allotment of DDA and vacant land in the vicinity on temporary basis may apply to the concerned SE(HQ) of the Zone in which the said land falls.
- The allotment of Community Hall / Land shall, as far as possible, be made on First Come, First Serve basis, subject to priorities detailed in the policy. DDA may verify genuineness of the applicant / purpose sought, before permitting the license.

DDA's flat conversion process goes digital

In the process of bringing more public services of DDA under online mode so as to facilitate the public availing them without physically visiting DDA office/s during the period of COVID-19 pandemic, it has been decided to completely switch over conversion process of DDA flats to online mode w.e.f 01.06.2021. Accordingly, no conversion application in offline mode shall be accepted by NSK nor shall they be processed by Housing department.

2. The General Public is therefore requested to apply for conversion of flats from leasehold to freehold in online mode only through DDA website. -

The 67th meeting of STF was held on 28.05.2021 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 15th May was reviewed.

During 01.04.2021 to 15.05.2021, demolition programme was carried out by DDA at the Eastern bank of River Yamuna near CWGV on 15.04.2021. Approx. 6.13 ha of land has been repossessed and on 19.04.2021 approx. 18 ha. of land was repossessed. Total 24 ha. of land was repossessed.

Joint encroachment removal action conducted by Revenue, SDMC, PWD and Delhi Police at MB Road (08.04.2021), 100 foot road (05.04.2021) and 55 N. Marg, Devli Road (6.4.21), 60 foot road (8.4.21) and IGNOU road (12.04.2021).

Encroachment Removal Action was taken by NDMC at areas including Connaught Place, Palika Bazar, Gole Market, Janpath, Regal and Rivoli and Shanker Market, Safdarjung, VVIP area, Sarojini Nagar and Chanakyapuri, AIIMS, Delhi Haat, East Kidwai Nagar during the period.



67th Special Task Force Meeting

In total 83566 complaints have been received in STF till 15th May 2021 and action on 79821 complaints has been initiated. 3258 ATR were received during the period from 01.04.2021 to 15.05.2021. Since the constitution of STF in 2018, 3621 unauthorised constructions have been demolished and more than 2423 properties have been sealed. Chairman, STF directed the ULBs to take the matter seriously and expedite the action on the pending cases.

Chairman, STF re-iterated that close co-ordinated efforts need to be continued by the ULBs & Govt. Agencies to take action for removal of encroachment in accordance with the law. Police Deptt. assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.
