The tender shall be submitted online in two parts, viz., technical bid and price bid. First cover containing "Technical Bid" as well as "reference of EMD, tender fee" and other specified documents and second one containing "Price Bid" (Financial Bid).
- The technical Bids shall be opened online in the presence of a committee or their representatives by 2. authorized bid openers. Similar nature means "Maintenance of Toilet / Bio Toilet work"

Turnover: -

The agency should have annual turnover of more than 50% of the estimate cost during the immediate last three consecutive financial years ended on 31st March, 2023 duly certified by the charted accountant.

Profit /loss: -

The agency should not have incurred any loss in more than two years during the last five years ending 31st. March, 2023.

Solvency Certificate: -

The agency should submit solvency certificate from scheduled bank for an amount 40% of the estimate cost which should not be more than six months old from the date of submission of tenders.
