On line sealed percentage rate tenders are invited through E-tendering mode for the following works by the Executive Engineer NMD-2, Mukherjee Nagar Kingsway Camp Delhi-110009 on behalf of DDA upto 3.30 P.M. on date (Mentioned below) from the approved and eligible contractors of appropriate class of the DDA & CPWD and those of appropriate list of MES, BSNL and Railway which shall be opened through e-tendering mode.

Earnest Money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O./CAU/NZ/DDA having SB account no.02871110000022 with HDFC Bank, B-3-2Ashok Vihar Phase-II, Delhi 110052 Branch (IFSC Code :- HDFC0000287). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tender are opened.

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money upto Rs.20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EM is more than Rs.20.00 lacs then the amount of E.M. beyond Rs.20.00 lacs can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.

The Unique transaction reference of RTGS/NEFT against EM and cost of tender document and Bank Guarantee shall be placed in single sealed envelope superscripted as "Earnest Money and cost of Tender Documents" with name of work and due date of opening of tender mentioned thereon and will submit to tender opening Authority. The officer inviting tenders shall have the right of rejection all or any of the tender and will not be bound to accept the lowest or any other tender.
