1. Eligibility Criteria

The firms /Contractors who fulfill the following eligibility criteria shall be eligible to apply. Joint ventures will not be accepted.

1.1 The contractor must be registered with DDA / CPWD / BSNL / RAILWAYS in appropriate class (Appropriate class shall be considered on the basis of EI work amounting to Rs. 9.12 Lakhs.

and

1.2 The bidder should have **satisfactorily completed** the following works in last 7 (seven) years ending previous day of last date of submission of bid. For this purpose, cost of work shall mean gross value of the completed work including cost of material supplied by the Government / private client but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer / Project Manager or equivalent.

Three similar completed works each of value not less than 40% of the estimated cost of specialized items of works i.e. Rs. 24,27,084 /- put to tender.

or

Two similar completed works each of value not less than 60% of the estimated cost of specialized items of works i.e. Rs. 24,27,084 /- put to tender.

1.3 <u>SOLVENCY CERTIFICATE</u> or <u>NETWORTH CERTIFICATE</u>

The bidder should have a Solvency of the amount equal to 40 % of the Estimated Cost put to tender (ECPT) certified by his Bankers. It should not be more than six months old as per Format-B-1.

or

The bidder should submit Networth Certificate of minimum 10% of estimated cost put to tender issued by the certified Chartered Accountant Upto the financial year 2019-20 (on the format prescribed in form B-2).

1.4 **<u>TURNOVER</u>**

Average annual financial turnover (gross) should be **at least 50%** of the estimated cost put to tender during the immediate last 3 consecutive financial years ending 2019-20. Financial statement duly signed by registered chartered accountant shall be submitted as a proof. Year in which no turnover is shown would also be considered for working out average.

1.5 **PROFIT / LOSS**

The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheets including 2019-20, duly certified and audited by the Chartered Accountant. (The balance sheet in case of Pvt./ Public Ltd. Company means its standalone finance statement both).
