# Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.

- 1. The unique transaction reference on RTGS against EMD shall be placed online at specified location for Tender for Electronic Time and Attendance Recording System. First cover containing "Technical Bid" as well as "reference of EMD".
- 2. The technical Bids shall be opened online at 11:00 AMon date 20.10.2025 in the presence of a committee or their representatives by authorized bid openers. Price Bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
- 3. The Tenderer should furnish Rs.14,823/- as Earnest Money in the form of NEFT/RTGS. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However no interest shall be payable on the earnest money.
- 4. The tender shall be submitted online in two parts, viz., technical bid and price bid.

- v. Scanned copy of Tender Acceptance Letter (To be given on Company Letter Head).
- vi. An undertaking (To be given on Company Letter Head) mentioning the NIT number/Name of work, and stating as under:
  - a) "I/We undertake and confirm that eligible similar work/work(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in DDA in future forever. Also, if such a violation comes to the notice of department before date of start of work, Engineer in-charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee"
  - b) I/We undertake and confirm that I/we have not been blacklisted by any Central /State Govt. /Municipal agency.
