Delhi Development Authority re-invites sealed quotations from specialized agencies for the following works, mentioned herein below. The quotation should reach the office of the Executive Engineer, NMD-3/DDA Office Complex, Ashok Vihar, Delhi-110052 by **3:00 PM on 27.04.2026**. The quotationers or their authorized representatives may be present at the time of opening of the sealed quotation. The sealed quotation shall be opened on the same day at 3:30 PM in the office of the EE/NMD-3. Only those agencies/ Firm/ Person having undertaken similar work (**Three or more similar nature of works each costing not less than 40% of the estimated cost put to quotation, or two similar works costing each not less than 60% of the estimated cost put to quotation, or one similar work costing not less than 80% of estimated cost put to quotation**) during the last seven years in Government Department or Public Sector undertaking with annual turnover more than 30% of the estimated cost in each year during the immediate last three consecutive financial year ending March 2025 duly certified by Chartered Accountant having valid UDIN are entitled to apply.

The earnest money in the form of Pay Order/Demand Draft of any schedule bank approved by the Reserve Bank of India drawn in favor of "Sr. A.O./CAU (NZ) DDA" to be submitted with the quotation. Any quotation which is not accompanied by the earnest money in the prescribed manner shall be rejected summarily and not accounted for at all.

The quotationers are required to submit following documents along with the quotation:-

- a) Scanned copy of Registration of PAN.
- b) Scanned copy of Registration of GST.
- c) Scanned copy of turnover certificate for last three consecutive financial years ending March 2025 duly certified by Chartered Accountant having valid UDIN.
- d) Scanned copy of Experience Certificates as per NIQ.
- e) Scanned copy of undertaking on a non-judicial stamp paper of Rs. 100/- that agency is not blacklisted or debarred by any Govt./PSU or private organization Agency/Firm/Person/Tenderer.

TERMS & CONDITIONS: -

- I. The work shall be carried out as per specification of work order/ CPWD specifications amended upto date & to the entire satisfaction of Engineer-in-charge.
- II. The following shall be the scope of work for the structural audit of the building:-

1. Visual Inspection & Preliminary Assessment

The scope under this stage shall include, but not be limited to, the following:

1. Conduct a detailed visual inspection of building.
2. Collect relevant data required for carrying out the structural audit.
3. Take necessary measurements, wherever required, to support the assessment.
4. Review available architectural and structural drawings.
5. Carry out a comprehensive photographic survey of the building.
6. Study and understand the existing structural system of the building.
7. Perform a rapid visual screening of the structure in accordance with **IS 13935:2009** and **IS 15988:2013** guidelines.
8. Identify and document defects in non-structural elements and mark critical structural stress zones.
9. Identify areas requiring detailed investigation and locations for conducting Non-Destructive Testing (NDT).
10. Conduct seepage and leakage assessment and identify defects in building services that may adversely affect the structural system.

2. Non-Destructive Testing (NDT)

1. Perform Non-Destructive Testing (NDT) as recommended by Engineer-in-charge.
2. The type and number of tests shall depend on site conditions, structural system, and observed distress.
3. The testing scope is flexible and may be revised based on findings during inspection.

3. Structural Analysis & Drawings

1. Compare the existing structural system with requirements of the latest applicable IS codes and prepare a comparative assessment, if required.
2. Perform structural analysis (e.g., using STAAD or equivalent software) in accordance with relevant IS codes, if required.
3. Evaluate analysis results against the existing structure and propose retrofitting/strengthening schemes, if necessary.
4. Prepare required structural drawings to support analysis and retrofitting design, wherever applicable.

4. Reporting & Recommendations


1. Submit a detailed structural inspection and assessment report.
2. Provide an evaluation of the structural stability and overall condition of the building.
3. Interpret and summarize results of NDT and other tests conducted.
4. Carry out diagnosis and root cause analysis of observed defects/distress.
5. Recommend suitable repair measures for identified deficiencies.
6. Suggest strengthening/retrofitting measures, where required.

7. Propose appropriate methodologies for structural strengthening and retrofitting.
8. Any other related work not specifically mentioned but required for satisfactory conducting the safety audit as per building norms and guidelines.

- III. Quoted rate should be inclusive of all taxes / levies including GST, payable under respective states, DDA will not entertain any claim, whatsoever in this regard.
- IV. The payment will be made after entire satisfaction of Engineer-in-charge.
- V. No T & P will be issued by Department.
- VI. No advance payment will be made to the agency.
- VII. Engineer-in-charge reserves the right to accept or reject any bid / quotation without assigning any reason.
- VIII. Engineer-in-charge reserves the right to debar the concerned agency if the work is not completed in stipulated time as work is found to be substandard.
- IX. Conditional quotation will not be accepted.
- X. Necessary statutory deductions as applicable will be made.
- XI. 10% Security Deposit will be deducted from the tendered amount.
- XII. No minor shall be engaged at site.
- XIII. Nothing extra will be paid to the agency by the department.
- XIV. Validity of Quotation is 60 days from the date of opening.
- XV. Debarred agency / or individual shall not be permitted to participate in the tendering process. Agency should be reputed and does not have any tarnished reputation.
- XVI. Any individual who has been debarred is not permitted to take part in any negotiations or represent an agency even if he holds a power of attorney on the agencies behalf. Any agency engaging debarred persons is also liable to debaring.
- XVII. The experience of agencies should be taken into account rather than individuals incorporated with the agency, which does not include proprietorship.
- XVIII. The quantities of items in schedule are tentative which may change depending upon site conditions.
- XIX. If the entire work is not done within the stipulated time mentioned in work order, it will be sole discretion of the engineer-in-charge to accept the work of item on such terms as the engineer-in-charge deemed fit and proper or to cancel the Work Order / to stop any payment against the work / to forfeit the earnest money or to debar the concerned agency. The decision of the Competent Authority in this behalf shall be final and not to be called in question before any Forum.
- XX. The contractor will be fully responsible during execution of work. If any loss/ theft/ damage caused at site/ surrounding, the same shall be made good with in quoted rates or recovered from the agency/shall be made good at agency's risk and cost.
- XXI. If any agency submits a faulty or incomplete tender for the first time, 20% of the earnest money so deposited shall be forfeited. However, if the agency commits fault or submits incomplete tender again in the subsequent tenders and the competent Authority finds that the default has been willful,


negligent or malafide in its intent, the earnest money shall be forfeited absolutely without assigning any reason and the tenderer shall not be allowed to participate in future tendering.

- XXII. In case the rates quoted by the bidders are same, then in order to arrive at a decision, a draw of lots shall be carried out by a Committee comprising of SE/NCC-1, EE/NCC-1 and AAO/NMD-3.
- XXIII. Based on real time feedback of members and administrative staff of DDA as and when a deficiency of service is noticed the same will be intimated to the agency/ contractor for rectification. In case there is no improvement/ rectification within prescribed period from the time of intimation proportionate deduction, as approved by the Competent Authority, shall be made from the agency/ contractor.
- XXIV. The work shall be completed within 30 days from the date of issue of the order.
