Terms & Condition:

1. No firm(s), Enterprises, Association of enterprises having same owner, partner or significant shareholder/promoter shall participate in the tendering process with the intentions of gaining undue advantage and causing adverse impact on the competition within India. In the event of force majeure, act of nature, unforeseen accident, application of any new law, any government guideline etc that has the effect of reducing the scope of the work or at once halting of work altogether, the DDA reserve the right to suspend or terminate the contract with immediate effect without giving any notice. 3. The agency should quote their rates inclusive of all taxes including GST payable under respective statutes. DDA will not entertain any claim, whatsoever, in this respect.
