**Eligibility Criteria**:-Only those agencies/ Firm/ having successfully completed similar works in following manner during last seven years ending last day of the month previous to the month in which tenders are invited, in Government Department or Public Sector Undertaking, , Govt. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% calculated from date of completion of work to last date of receipt of application for the tenders.

#### Turnover: -

The agency should have annual turnover of more than 50% of the estimated cost during three financial years out of last five years duly certified by the charted accountant having valid UDIN.
