Any person/agency having nil experience and no annual turnover are also entitled to submit the tenders. The bid not submitted in accordance with the prescribed manner will not be accounted for.** The cafeteria / snack bar is located at CWG Village Sports Complex DDA, Akshardham Delhi -110092.

In Part – I of the tender, i.e. Technical Bid, the tenderer shall upload details of ownership/management of the agency. In case of company / firm, an attested copy of registration certificate and Article of Association is also to be furnished. In case of a partnership firm, the partnership deed, registration will be submitted and in case of a proprietorship firm the details of all proprietors and the percentage ownership in the proprietorship concern.

**In Part – II** of the tender should contain financial bid indicating monthly licence fee (per month) offered by the tenderer. The offer should be given in both words & figures.
