Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.

- Bidder registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under :-

- The unique transaction reference of RTGS/NEFT against EMD etc, shall be deposited online at specified location for Electronic Time and Attendance Recording System for tender.
- The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.

4. The tenderer should furnish Rs. 31,022.00 Earnest Money in the form of RTGS/NEFT. The Earnest Money will be returned to unsuccessful bidder. Earnest Money of successful Bidder will be returned only after receiving the performance Guarantee, however no interest shall be payable on the earnest money.
5. The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
6. To become eligible for issue of tender, the tenderer to furnish an affidavit as under: -  
"I/We undertake and confirm that I/we have not been blacklisted by any Central /State Govt./Municipal agency upto the date of submission of above-mentioned tender. If such a violation comes to the notice of the department before the date of start of work the Engineer in charge shall be free to forfeit the entire amount of earnest money deposit/performance guarantee.
