The tender shall also be issued to Non-DDA, Non-CPWD contractors provided they have satisfactory completed three similar nature of works, each of value not less than 40% of the estimated cost or two similar nature of works each of value not less than 60% of the estimated cost or one similar nature of work value not less than 80% of the estimated cost in the last 7 years ending last day of month previous to the one on which the tender are invited.
- Similar nature of work means "Road work.
- The intending tenderer should ensure before tendering in DDA that the requisite fee has already been deposited with CRB, DDA.
- The Bidder May Either Have His Own Batch Mix Type Hot Mix Plant Or MOU with The plant Owner. The Plant should comply all the instructions/rules as issued by Central Pollution Control Board/State Pollution Control Board/ National Green Tribunal Form Time to time The Batch Mix Plant Owner Must have No Objection certificate from CPCB/SPCB/NGT.

**Important terms & conditions for tenderers. Tenderers are required to go through the same before participating in the tender.**

1. Bidder registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under :-

The other Contractors not listed with DDA will deposit Rs. 20,000/- + 18% GST per year in CRB of DDA before uploading their tender online.

Requisite e-tendering fee as applicable payable to the CRB, DDA shall be in form of Pay order/Bank demand draft payable in Delhi in the name of "PAO, Engineering Wing, DDA, Vikas Minar, New Delhi". A letter on firm's letter head enclosing the demand/pay order and addressed to "The Secretary CRB, Ist Floor, Vikas Minar, DDA, New Delhi shall be submitted to contractor's Registration Board, Ist Floor, Vikas Minar, I.P. estate New Delhi-1100001 in duplicate and acknowledge stamped copy of the letter shall be uploaded in the tender as a proof of registration with the CRB, DDA.

**NOTE: In case any contractor fails to make payment by the stipulated date, the concerned contractor will not be eligible for tendering.**

2. The unique transaction reference of RTGS/NEFT against EMD etc, shall be deposited online at specified location for Electronic Time and Attendance Recording System for tender.
3. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
4. The tenderer should furnish Rs 6,25,842.00 as Earnest Money in the form of RTGS/NEFT. The Earnest Money will be returned to unsuccessful bidder. Earnest Money of successful Bidder will be returned only after receiving the performance Guarantee, however no interest shall be payable on the earnest money.
5. The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
6. Documents of Ownership of Batch Mix Type Hot Mix Plant Or Mou (Memorandum of Undertaking) on non-Judicial Stamp Papers of Rs. 100/- with The plant Owners along with NOC from Central Pollution Control Board/ State Pollution Control Board/ National Green Tribunal. (Specifically For This Work.)
7. To become eligible for issue of tender, the tenderer to furnish an affidavit as under: -  
"I/We undertake and confirm that I/we have not been blacklisted by any Central /State Govt./Municipal agency upto the date of submission of above-mentioned tender. If such a violation comes to the notice of the department before the date of start of work the Engineer in charge shall be free to forfeit the entire amount of earnest money deposit/performance guarantee.

11. Undertaking on non-judicial stamp paper of Rs 100/- as per 1.2.3 at page 10 (This will apply to all contractors participating in the tender).


12. Certificate of financial turnover from C.A. The turnover should be as follows: "Average annual financial turnover should be at least 30% of estimated cost put to tender during the immediate last three consecutive financial year. The value of annual turnover shall be brought to current value by enhancing the actual turnover figures at simple rate of 7% per annum. (Not applicable for DDA and CPWD enlisted /registered contractors in the appropriate category).

13. Documents of Ownership of Batch Mix Type Hot Mix Plant Or Mou (Memorandum of Undertaking) on non-Judicial Stamp Papers of Rs. 100/- with The plant Owner along with NOC from Central Pollution Control Board/ State Pollution Control Board/ National Green Tribunal. (Specifically For This Work.)
