Eligibility:-

- On-line percentage rate bids are invited through e-Tendering mode by the Executive Engineer, Eastern Maintenance Division-7 on behalf of Delhi Development Authority from the approved and eligible contractors of DDA. NOTE-As per letter issued by AE/CRB/DDA vide letter no. F4(8)72/Misc./Secy./CRB/2022/751 on dt. 30.12.2022 for which works, costing upto Rs. 130.00 lacs registered and approved contractors of DDA will only be eligible.
- The intending tenderer should ensure before tendering in DDA that the requisite fee has been already deposited with CRB, DDA.

Bidder registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:-

- The unique transaction reference of RTGS/NEFT against EMD etc. shall be deposited online at specified location for Electronic Time and Attendance Recording System for tender.
- The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
- The tenderer should furnish **Rs. 53,276.00** as Earnest Money in the form of RTGS/NEFT. The Earnest Money will be returned to unsuccessful bidder. Earnest Money of successful Bidder will be returned only after receiving the performance Guarantee, however no interest shall be payable on the earnest money.
- The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.

5. To become eligible for issue of tender, the tenderer to furnish an affidavit as under:-

"I/We undertake and confirm that I/we have not been blacklisted by any Central /State Govt./Municipal agency upto the date of submission of above-mentioned tender. If such a violation comes to the notice of the department before the date of start of work the Engineer in charge shall be free to forfeit the entire amount of earnest money deposit/performance guarantee."

The Tender shall be submitted online in two part, viz, technical and Price bid


Technical Bid:-

The tenderers are required to furnish following documents in technical bid:

1. Scanned copy of Earnest Money deposited through RTGS/NEFT in the account CAU EAST ZONE EMD, having account No. 13940110040416 with UCO Bank, Shahpurjat, New Delhi Branch (IFSC code - UCBA0001394).
 2. Scanned copy of unique transaction reference of RTGS/NEFT.
 3. Scanned copy of Proof of Payment of E-tendering fee in CRB of DDA.
 4. In case of partnership firm, **General Power of Attorney** in favour of person who is authorized to sign the documents and **Partnership Deed** shall also be uploaded.
 5. Scanned copy of Enlistment Order of the Contractor.
 6. Scanned copy of certificate of Registration for GST. (Provisional/Applied/Permanent)
 7. Scanned copy of PAN no., ESI, EPF registration.
 8. Scanned copy of Tender Acceptance Letter strictly as per the format in NIT at page 14 (It is mandatory to be given on Company Letter Head and Tender Acceptance Letter should clearly mention N.O.W, S.H, N.I.T reference and it shall be dated after the uploading of tender and shall be addressed to EE/EMD-7/DDA, Sarita Vihar Pocket-A, New Delhi-110076).
 9. Duly notarized affidavit, (Article 4) dated after the uploading of tender notice as per para 1.2.3 at page No.07 on non-judicial stamp of Rs. 100/- (The first and second party name shall be agency and DDA name respectively in the stamp paper). Affidavit should clearly mention N.O.W, S.H, N.I.T reference and it shall be dated after the uploading of tender and shall be addressed to EE/EMD-7/DDA, Sarita Vihar Pocket-A, New Delhi-110076)
 10. Scanned copy of cancelled cheque.
