## E-TENDER NOTICE NO. 03 SFSC | DDA | 2024-25

Online tenders are invited through e-tendering mode on behalf of Chairman, Delhi Development Authority for the following works at SIRI FORT SPORTS COMPLEX, DDA: Running of Golf Pro-shop (Sports Equipment) at Driving Range of SIRI FORT SPORTS COMPLEX, DDA on Monthly License Fee Basis for a period of 3 years (extendable upto 9 years). The tender shall be in two parts viz 'Part-I' containing Technical Bid and 'Part-II' comprising 'Financial Bid'. Only those agencies having a minimum five years experience in last 10 years in the field of Running of Golf Pro Shop, and having club fitting and club making facilities in government bodies, PSU's, renowned/reputed private golf courses and having a minimum average annual turnover of Rs. 50.00 lacs from running of golf pro-shop only for the last three financial years are entitled to submit the tenders. The bid not submitted in accordance with the prescribed manner will not be accounted for. The Golf Pro Shop is located at the driving range having a total covered area of 30.52 Sq.mtrs. at SIRI FORT SPORTS COMPLEX, DDA August Kranti Marg, New Delhi - 110049.

In Part – I of the tender, i.e. Technical Bid, the tenderer shall upload details of ownership/management of the agency, experience of similar nature of works undertaken by them i.e. copies of award letters and certificates of satisfactory completion, duly attested, authenticated proof showing annual turnover, manpower available with them, their qualifications and experience in the field etc. In case of company/firm, an attested copy of registration certificate and Article of Association is also to be furnished. In case of a partnership firm, the partnership deed, registration will be submitted and in case of a proprietorship firm the details of all proprietors and the percentage ownership in the proprietorship concern.

In Part - II of the tender should contain financial bid indicating monthly license fee (per month) offered by the tenderer. The offer should be given in both words & figures.

- 1. The bidders will deposit a non-refundable fee of Rs. 500/- plus GST @18% per tender through RTGS/NEFT in the account of "CAU SPORTS DDA" having Account No. 1611994900 with "Kotak Mahindra Bank, Gulmohar Park, New Delhi, (IFSC. KKBK0000184)." and upload the UTR number along with payment details on-line. It may be noted that this account is different from EMD deposition account.
- 2. In case, tender is re invited for any reason, the bidder who has already paid the tender fee previously may not be required to resubmit the tender fee again.
- If any bidder withdraws its bid or act in any manner that leads to cancellation of tender or re-invitation of tender and if the Competent Authority allows such bidder to participate in future tendering, even then no adjustment of tender fee would be allowed as stated in point 2 above.
- In case any contractor fails to make payment by the stipulated closing date of bid submission, the concerned contractor will not be eligible for tendering.

No hard copy of any document will be required to be submitted by the tenderers till the opening of the tenders. Hard Copies of relevant documents will be required from the highest bidder only.

The tender shall be submitted online in two parts, viz., technical bid and price bid.

- Scanned copy of an Undertaking on non-judicial Rs 100/- Stamp paper with clauses as below:
  - a. The agency shall be solely liable for any penalty levied by the ESI/EPF departments for not having paid mandatory ESI/EPF contribution and an undertaking on stamp paper to this effect shall be submitted.
  - b. If the agency claims that it is not obligated to get itself registered under the ESIC and EPF acts (and doesn't submit proof of registration with EPFO and ESIC) then the same may be undertaken on a stamp paper.
  - c. All statutory payment including Bonus, covered under any law/statute, shall be the sole responsibility of bidder and DDA shall be protected by the licensee from any financial obligation that may arise due to non-compliances of any government law, policy, guidelines, statute etc.
  - d. Scanned copy of undertaking on a stamp paper that the agency is not blacklisted or debarred by any Govt. /PSU or private organization Agency/Firm/Person/Tenderer at the time of Bid submission.
