Only those Agencies/ Firm/ Person having successfully completed three similar nature of works each costing not less than 40% of the estimated cost put to tender, or two similar completed works each costing not less than 60% of the estimated cost put to tender, or one similar completed work costing not less than 80% of estimated cost put to tender during the last seven years ending previous day of last date of submission of tender in Government Department, Public Sector undertaking and Private Sectors for running of Restaurant are entitled to apply and the proof thereof should be enclosed with the Technical Bid. The tenderer should be registered with the GST Department and furnish a copy of registration with the tender.
