EMPANELMENT OF SURVEY AGENCY FOR SURVEY AND Management Information System (MIS) ENTRY OF JJ BASTIS/CLUSTERS ON EXISTING DDA AND CENTRAL GOVERNMENT LANDS IN GNCT OF DELHI FOR THE INSITU REHABILITATION

Introduction

DDA intends to create a comprehensive database of JJ dwellers and JJ clusters for rehabilitation. The intended database will comply with the requirement of Pradhan Mantri Awas Yojna (Urban) and will be collected as per the existing rules, acts and guidelines and needs to be verifiable in the field.

In order to achieve the aforesaid objective, as a first step, DDA wishes to empanel reputed agencies, who will carry out the survey and collect the details in standard forms.

Objectives of Survey

To assess number of people and households in approximately 173 JJ Clusters with documents on their status and eligibility for resettlement/in-situ development program.

Stakeholder analysis to understand people's perception of their problems, aspirations and provide inputs that would be useful to consider and development plans including social housing.

To assess the affordability of the people for housing and housing finance.

To develop suitable housing and related indicators, that would be useful for monitoring, evaluation and planning.

To provide survey data in electronic form for populating GIS that could be taken care of by DDA for its various program.

Scope of Survey and Methodology (please refer Annexure-I for detailed scope of work)

The survey will be on house to house basis and the data will be collected in the prescribed format. The survey will cover every household in about 173 JJ clusters as per the list attached, there may be more households required to be surveyed since the clusters may have expanded over time. After data entry of the survey and compilation of the information it should be presented before the community for ratification to ensure that no households are left out in the survey process and the data collected is accurate.

The JJ clusters are located across the city and fall under the jurisdiction of Divisions into which Delhi is divided for purposes of administration. It is estimated that the total population may be about 4.00 lakh. If during the survey, necessity to conduct survey for some additional JJ clusters beyond 173 clusters arises, the same would be also included.

Demand Survey & MIS entry in prescribed format.

Expected output

The agency must capture the data in electronic format through android based mobile app based on which the all the survey form will be generated and signed so as to use the data for following purposes:

-

Identify location of the households with appropriate documentation.

A comprehensive household database

Time Frame

The work will have to be completed within 180 days of giving work order/award letter. various activities viz pre-survey preparation, survey schedule, training manual, training, survey logistics, actual survey, data entry, programming & process, analysis and report drafting, presentation and production of final report etc. will have to be completed by the agencies within the given time frame as indicated above.

Minimum Qualification

The Agency is required to produce documentary evidence of experience/ Projects will only be considered if they have been completed and completion certificate from the client is enclosed. All documents must be verified as true and countersigned by authorized signatory.

Must have an average annual turnover of at least 5 lacs per year in the last 3 consecutive financial years, ending March, 2024.

Must have carried out at least 2 projects in last 5 financial years involving field survey and data collecting of more than 40000 households in total.

Must have carried out at least 1 project for government or PSU or a govt undertaking in any of the last 5 financial years involving field survey and data collection.

Must be profitable for 2 financial years during last 3 years.

Declaration on letter head of the Agency, that the Agency has not been black listed by any of the government/ government departments any where in India in last 2 financial years.

Note: In case of works executed for the private clients, cost of such works shall be supported by TDS certificates along with VAT/GST & Service Tax Return and also self certification of experience shall not be considered.

The Agency, shall submit a written power of attorney/authority letter authorizing the signatories for empanelment.

If the Agency is a proprietorship firm then, the Agency shall submit a copy of PAN card No. under the Income Tax Act.

Agency must submit copies of all documents required along duly self- attested by authorized representative of the Agency.

Agency shall submit a Bank Guarantee of Rs.200,000/- in the prescribed format (to be provided by the department)

Agency is required to confirm and declare that no agent, middleman or any other item or work related to the award and performance of this work order. Agency will have to further confirm and declare that no agency commission or any payment, which may be construed as an agency commission, has been or will be paid and that the cost of survey per household will not include any such amount. If DDA subsequently finds to the contrary, the DDA reserves the right to declare the Agency as non-complaint and declare any contract if already awarded to the bidder to be null and void. (Enclose declaration)

Canvassing or offer of an advantage or any other inducement by any person with a view to influencing acceptance of offer will be an offense under Laws of India. Such action will result in the rejection of bid in addition to other punitive measures.

Audit

Empanelled Agency shall comply with the DDA's internal audit (including Information Security (IS) Audit) requirement as well as third- party external auditors for conducting periodical audit. The Agency should carry out patch management activities, including Operating System (OS) hardening for the infrastructure deployed as well as changes required in hardware and software for disclosure of Vulnerability Assessment and Penetration Testing (VA/PT) & audit reports without any extra cost to DDA.

The Agency shall at all times whenever required furnish all information, records, data stored in whatsoever form to internal, external, DDA appointed and statutory inspecting auditors and extend full cooperation in carrying out of such inspection. The Agency will also undertake to co- operate with the CAG to carry out its supervisory functions and objectives and will furnish all records and other information as CAG may call for to carry our inspection and/or other functions.

The Agency is required to facilitate the same at no additional cost and shall provide uninterrupted access to the documents required by the auditors. Further the Agency has to ensure rectification of all the irregularities thus pointed out by the auditor within a given time frame.

The Agency must ensure compliance of Information Security (IS) according to policy of the DDA and mitigate the risk, if any, within the stipulated time without any additional cost to DDA.

In line of above, the Agency shall ensure that all regulatory, statutory, local Administration requirements are adhered to subsequently while undertaking deliverable and services over the period of contract without any additional cost to DDA.

Compliance with security best practices may be monitored by periodic computer/information security audit performed by or on behalf of the DDA. The periodicity of these audits will be decided at the discretion of the DDA: These audit plan to include, but are not limited to, a review of: access and authorization procedures, physical security controls, input/output controls, Database controls, backup and recovery procedures, network security controls and program change controls.

To the extent that the DDA deems it necessary to carry out a program of inspection and audit to safeguard against threats and hazards to the confidentiality, integrity, and availability of data, the Agency shall afford the DDA's representative access to the Agency's facilities, installations, technical resources, operations, documentation, records, databases and personnel. The Agency must provide the DDA access to various monitoring and performance measurement system (both manual and automated). The DDA has the right to get the monitoring and performance measurement systems (both manual and automated) audited without prior approval / notice to the Agency.

Project Duration and Extension of Service thereafter

The contract will initially be for the project period, including O&M, for the period mentioned in the empanelment letter and extension shall be granted after the performance review on expiry of the empanelment period However, the assignment may be terminated any time at the discretion of DDA without assigning any reason thereof if the services are not found satisfactory or service/services are not required by DDA after certain period.

Reports

Empanelled Agency shall maintain Records and database of Applicants and submit quarterly return in the Format prescribed by DDA, in digitalized database form.

The Agency will ensure that all works envisaged under the assignment are carried out in discussion with and to the satisfaction of DDA and will submit reports during the contract period, as may be required by the DDA from time to time.

Annexure-I

SCOPE OF WORK

The scope of work for the agency would involve the following:-

Collection of household data for JJ Bastis assigned to the agency, as per Delhi slum and Jhuggi Jhopadi Rehabilitation & Relocation policy 2015 (as available at DDA site)

Agency shall make wider publicity of such survey as per direction of DDA. The agency must capture the data. In electronic format through an android based mobile app based on which the survey form will be generated and signed. The agency shall conduct door to door beneficiary demand survey and collect data of households of JJ Bastis as prescribed in the Data Collection form (Format 4 of PMAY guidelines- Annexure XIV and/ or as per the requirement of DDA with family photo.

The agency shall also identity new slums if any as per guidelines of PMAY and conduct demand survey of these slums

The agency will provide field supervision, quality control of the conduct of the survey and daily field checks of data completion and consistency will be provided to a standard to be agreed with DDA.

Provide daily update through Android based app (DDA will provide only the app. Equipments including data charges required for running the app shall be arranged by the Agency) or email/telephone/SMS as per the directions of Nodal Officer in DDA of household data collected in survey format and information of data fed in the electronic system/MIS of PMAY portal.

Agency shall provide rough sketch plans of JJ Bastis showing the demarcation of jhuggi clusters/bastis and their respective areas.

The survey of JJ Clusters shall be supervised and the data will be finalized for eligibility by In-situ Rehabilitation branch, Housing DDA in addition to Engineer-incharge, DDA.

The deliverables are:-

Compilation of demand survey of the Bastis in electronic form.

Complete survey forms based on electronic data for all JJ Jhopadis in allotted JJ Bastis to be uploaded on DDA server.

Agency shall provide rough sketch plans of JJ Bastis showing the demarcation of jhuggi clusters/bastis and their respective areas.
