Executive Engineer (E), Electrical Division no. 13 on behalf of Delhi Development Authority Re-invites online percentage rate bids from approved & eligible contractors of DDA, CPWD, BSNL, Railways & those of appropriate list of MES and P&T in **Two Bid System** for the following work:

Note:- a) The tenders shall be issued to DDA enlisted contractors of appropriate class in Electrical category. The tender shall also be issued to non-DDA, contractors (those of appropriate list of CPWD, MES, BSNL, Railway provided they have satisfactorily completed three similar nature of works each of value not less than

40% of the estimated cost, two similar nature of works each of value not less than 60% of the estimated cost, one similar nature of work of value not less than 80% of the estimated cost in last seven years.

b) Similar class of work means “General Electrical work i.e. Original/Project or maintenance works”. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid.

1. The intending bidder must read the terms and conditions of CPWD-7 carefully, He should only submit his bid if he consider himself eligible and he is in possession of all the documents required. Information and instructions for bidders will form part of NIT & to be uploaded on website.
2. Information and instructions for bidders posted on website shall form of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from www.dda.org.in or central public procurement portal [https:// eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app) free of cost.
Those contracts not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website. The intending bidder must have valid class – II digital signature to submit the bid.
4. But the bid can only be submitted after depositing E – tendering processing fee, and uploading the mandatory scanned documents.

Note:- Bidders registered in Contractor’s Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:-

Note:- The bidders who are not registered in DDA and wish to bid in DDA tenders are required to pay annual charge of e-tendering to Secretary CRB, DDA in prescribed form as are under:-

Earnest money shall be deposited through RTGS/NEFT in the account of Sr. Account Officer CAU (Horticulture) DDA having Account no. 01201110000010 with HDFC Bank GF- 01,02,03 Laxmi Deep Building Laxmi Nagar Distt Centre Vikas Marg , Delhi 110090 (IFSC code HDFC0000120). The unique transaction reference of RTGS / NEFT shall have to be scanned & uploaded by the bidder in the e-tendering system within the period

of bid submission. (The Executive Engineer, ELD-13 will get earnest money verified from CAU based on the unique transaction reference number against each RTGS / NEFT payment before the bids are opened).

Earnest money has to be deposited through separate transaction.

Interested contractor who wish to participate in the bid has also to make following payments.

The unique transaction reference of RTGS / NEFT against EMD shall be submitted to tender opening Authority by the lowest bidder within one week of demand.

The bid submitted shall be opened at 03:30 pm on 17.12.2024.

Note:- "The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different bids, the entire bid submitted by him will be rejected and he will be debarred from further bidding in DDA in future."

Note:-GST@18% (CGST@9% & SGST@9%) is to be levied alongwith tendering/processing fee from all the registered/not registered/ to be registered contractors.


Proof of registration (if applicable) and the proof of payment and its scanned copy are to be uploaded.

5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website.
6. The intending bidder must have valid class-II digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Contractor can upload documents in the form of JPG format and PDF format.
9. Contractor must ensure to quote rate of each item. In addition to this while selecting any of cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
10. ~~Pre Bid conference shall be held in the chamber of SE (E) at _____*_____ on _____*_____ to clear the doubt of intending tenderers, if any.~~
11. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many tenders are received satisfying the laid down criterion.

- ii) Scanned copy of proof of payment made for processing fee charges as detailed in para 4 above (Note:- The E-tendering Fee submitted in other category i.e. building and road or Hort. is not applicable and tender will be rejected in case of such fees).
- iii) Certificate of Registration for GST and acknowledgement of up to date filed return
- iv) Registration of ESI and EPFO (Note:- An undertaking on Rs.50/- Non Judicial Stamp paper in case not applicable as per prescribed format H and L-1 tenderer bill submit original copy in ELD-13/DDA).
- v) Scanned copy of Tender Acceptance Letter, as per attached format.
- vi) Corrigendum to tender uploaded before opening of tender (if any).
- vii) Proof of enlistment /registration. (if not registered in DDA, Agency must provide experience certificate as per note a & b)
- viii) Electrical Contractor License.
