- The plants/Grass supplied should be in good quality, healthy and free from disease. 16.
- The contractor/tenderer must be enlisted as Horticulture Category Contractor. 17.
- The contractor should be supplying the total quantity of all items mentioned in schedule of 18. quantity/agreement. If contractor failed to supply the materials as per agreement or as per direction of Officer-in-Charge, then the recovery shall be made as perjustified rate.

In case of items of water through water tankers only

- 1. The P.H. value of water should be got tested from authorized laboratory on contractor cost.
- 2. The water supplied must be free from any kind of pathogens and waste and suitable for irrigation of plants.
- 3. Water tankers can be used for filling of overhead tank and nothing extra shall be paid on this account.
- 4. Tankers should be supplied with pressure pump technology.
- 5. The treated STP water supplied through water tanker is to be received from STP of DJB and the receipt/challan should be submitted to officer-in-charge (Hort.)
- 6. If any casualty occurs due to non-supply of water tanker, then penalty will be imposed @ rate 25% in addition to the justified rate of water tanker.
