On-line percentage rate bids are invited through e-Tendering mode by the Executive Engineer, Eastern Maintenance Division-7 on behalf of Delhi Development Authority from the approved and eligible contractors of Central Government/Central Autonomous Body/ Centre PSU'S/State Govt./State PSU'S Municipal bodies etc. with the conditions mentioned for the following work.

Earnest money and cost of tender shall be deposited through RTGS/NEFT in the account of Dy. Chief Accounts Officer, Project Zone ( i.e.CAU/EZ) having account No. 13940110040416 with UCO bank at Shahpurjat New Delhi:-110016, DDA Shopping Centre (IFSC code UCBA0001394. The UTR of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive engineer concerned will get tender cost/ earnest money verified from CAU based on the UTR number against each RTGS/NEFT payment before the tenders are opened.

A part of the Earnest money is acceptable in the form of bank guarantee also. Earnest Money up to Rs 20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EMD is more than Rs.20.00 lacs then it can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.

The UTR number of RTGS/NEFT against EMD and Cost of tender document and Bank Guarantee shall be placed in single sealed envelope superscripted as "Earnest Money and Cost of Tender Document" with name of work and due date of opening of the tender mentioned thereon and will submit to tender opening authority. The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.

**Note:**

Only those agencies are eligible for uploading their Tender who have successfully completed similar nature of works under Central Govt./Central Autonomous Body /Central PSU's/State Govt./State PSU'S, Municipal Bodies etc. provided they should have satisfactorily completed the following works in last 7 (seven) years ending previous day of last date of submission of bid. For this purpose, cost of work shall mean gross value of the completed work including cost of material supplied by the Government / client but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer / Project Manager or equivalent.

Three similar completed works each of value not less than 40% of the estimated cost put to tender.

or

Two similar completed works each of value not less than 60% of the estimated cost put to tender.

or

One similar completed work of value not less than 80% of the estimated cost put to tender.

All amounts rounded off to a nearest convenient full figure.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to previous day of last date of submission of bid.

The similar nature of work means: Cleaning/ Sweeping etc.

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. The intending tenderer shall have to register them with GST.
3. Information and Instructions for bidders posted on website shall form part of bid document.
4. The bid document consisting of plans, specification, the scheduled of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website Central Public Procurement Portal for e-Procurement at [www.eprocure.gov.in/cpppor](http://www.eprocure.gov.in/cpppor) [www.dda.org.in](http://www.dda.org.in). 5. But the bid can only be submitted after uploading the mandatory scanned documents such as unique transaction reference of RTGS/NEFT towards cost of bid document, EMD and other documents as specified.
6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have valid class-II/III digital signature to submit the bid.
8. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.

9. Bidder can upload documents in the form of JPG format and PDF format.

**NOTE:**

- 1) The Bidders should ensure before tendering in DDA that the requisite fee has already been deposited with CRB. The bidders should also enroll on the above mentioned website before tender submission.
- 2) The Bidders will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.
- 3) Further all updates, corrigenda, Addenda, Amendments, Time extensions, Clarifications etc., (if any) to the tender will be hosted in the above website only. There will not be any publication of the same through newspapers or any other media. Bidders should regularly visit above website to keep themselves updated.

  5. Scanned copy of Tender Acceptance Letter (It is mandatory to be given on Company Letter Head).
  6. Affidavit on Rs. 100 Stamp Paper as per Para 8.1 of P-11 (Latest Stamp paper as per Article 4 shall be available with Affidavit for each work separately which must be notarized by the concerned authority)
  7. The tenderer should ensure before tendering in DDA that requisite fee for e-tender processing (annually) has been deposited with CRB cell of DDA and shall upload the receipt.
  8. Certificate of registration with EPFO & ESIC or proof of applying thereof.
